WHEREAS, Cal joined Puget Sound Energy (PSE) in 2002 ultimately becoming Vice President for Customer Solutions; and

WHEREAS, Cal's commitment to energy efficiency has instilled PSE with a proconservation culture, enhancing PSE's reputation as a utility that is serious about conservation and with the result that PSE's energy savings increased over 350 percent from 2002 to 2012; and

WHEREAS, Cal served several years on the Board of Directors of the Northwest Energy Efficiency Alliance (NEEA), and ultimately its Chair in leading its market transformation activities and a new strategic plan to guide its efforts in the future; and

WHEREAS, Cal actively served on the Executive Committee of the Northwest Energy Efficiency Task Force (NEET), which was established under the direction of the Co-Chairs BPA and PacifiCorp to develop consensus in the region around key issues to facilitate greater energy efficiency; in particular, Cal chaired the Workgroup #5 to develop recommendations to enhance energy efficiency workforce capabilities in the Pacific Northwest; and

WHEREAS, Cal successfully implemented PSE's conservation obligations under the Energy Independence Act, with great success; and

WHEREAS, in the course of his career with PSE, Cal oversaw the development of the Conservation Resource Advisory Group, building relationships among PSE staff, representatives of the Washington Utilities and Transportation Commission, and other interested parties and, in the process, earning the respect of all; and

WHEREAS, Cal has provided tireless mentoring and leadership both inside and outside of PSE through his interactions with Commission staff, encouraging, teaching, and coaching with sincerity and wisdom; *now*, *therefore*, *be it* 

**RESOLVED**, That the members and staff of the Washington Utilities and Transportation Commission express their sincere thanks to Cal Shirley for his contribution to PSE, to the Commission, and to the State of Washington for his tireless efforts to promote energy efficiency; *be it further*
