**NOTICE OF CESSATION OF
TELECOMMUNICATIONS SERVICE**

- 1 Pursuant to WAC 480-120-083, Integra Telecom of Washington, Inc. and its Washington affiliates¹ (together, "Integra") hereby provide notice of the cessation of a telecommunications service known as Scan Alert. This service is currently offered on a resold basis.²
- 2 Scan Alert allows alarm monitoring by alarm companies that provide service in the same areas in which Integra provides service. The reason for Integra's cessation of the service is that CenturyLink will soon cease to offer the service. CenturyLink has stated that it has encountered technical limitations with Scan Alert due to the fact that production of the equipment necessary to maintain the service has been discontinued and replacement equipment supplies have been exhausted.
- 3 The following sets forth the information regarding notifications required by WAC 480-120-083.
 - a. Subsection (2)(a) of the rule requires notification to the Commission at least 30 days in advance. The service is scheduled to be discontinued on December 1, 2013.
 - b. Subsection (2)(b) deals with 911 services and does not apply to this service.

- c. Subsection (2)(c) requires notice to customers, including any resellers, at least 30 days in advance. CenturyLink initially notified Integra of the pending cessation of the Scan Alert service in April 2013 and the Company began discussions with its Scan Alert customers almost immediately. At this time, Integra has only two customers with active Scan Alert service; those customers have been notified by telephone on multiple occasions, with written notice mailed most recently October 31, 2013.
- d. Subsections (2)(d) and (e) apply if the exiting carrier is supplied by other carriers and does not apply in this case.
- e. Subsection (2)(f) requires notice to the numbering administrator if numbers are to be returned. The number of telephone numbers associated with Integra's provision of this service is so small and not in the quantity typically involved with the return of numbering resources, thus Integra does not believe a notice is required.
- f. Subsection (3) requires the Commission notice to contain certain information. This notice contains the information required under Subsection (3) of the rule. The number of customers for each telecommunications service and their location, described by exchange or by city and county for each telecommunications service being ceased is as follows: 2 customers, 2 lines, located in greater Seattle, legacy Qwest exchanges.
- g. Subsection (4) requires the customer and Commission notice to contain certain information. A copy of the most recent customer notice is attached; the notice contains the information required under Subsection (4) of the rule. Further, Integra continues to try to directly contact its Scan Alert customers and will continue to do so.
- h. Subsections (5) and (6) do not apply to Integra's cessation of Scan Alert.
- i. As discussed in e., above, Integra believes that Subsection (7) requirements for the notice to the numbering administrator do not apply.

j. Subsections (8) and (9) do not apply to Integra's cessation of Scan Alert.


