Dear Mr. King:

Pursuant to RCW 80.28.060 and Chapter 480-80 WAC, please find enclosed for filing the following proposed revisions to the WN U-60, Tariff G for electric service of Puget Sound Energy (the “Company” or “PSE”).

Ninth Revision of Sheet No. 91-a - Schedule 91 – Cogeneration and Small Power Production
(Continued)**

The purpose of this filing is to update the fixed-price option for qualifying facility customer-generators under Schedule 91. Consistent with WAC 480-107-095, the Company offers a standard tariff for purchases from qualifying facilities.

The methodology used to update the fixed-price alternative is consistent with the approach used in the 2007 through 2012 annual filings, where a market price forecast is generated using the Aurora model and a planning adjustment is used to adjust that market forecast for the capital costs of PSE’s energy supply portfolio. In addition to that adjustment, a calculation is made to place a value on avoided capacity costs using the cost effectiveness standard model for conservation programs. The resulting price is then reduced by 5% for balancing costs.

The market price forecast used to develop the prices in this filing reflects PSE’s most recent forecast that is also the basis for the Company’s 2013 Integrated Resource Plan. Each year the update of the Schedule 91 fixed-price option incorporates the currently available power price forecast, capacity cost, and discount rate assumptions used in other PSE power cost analyses.


This filing also clarifies the determination of the monthly rate and includes a replacement for the Dow Jones Mid-Columbia Index.
