UE-111048 and UG-111049 (the “Order”) and the Multiparty Settlement Stipulation Re: Electric Rate Spread, Electric Rate Design And Renewable Energy Credit Tracker (“Settlement Stipulation”) approved by the Order to make a filing to reset rates effective date of January 1, 2014, and (2) to include the net proceeds, through October 31, 2013, related to biogas acquired by the Company in accordance with the Commission’s order in Docket No. UE-131276.


