Proposed Rate Change Re-Filing

Dear Mr. King:

Enclosed is a proposed general tariff filing with an effective date of June 16, 2014. This tariff change is being sought to (1) cover increases in operating costs since our last rate filing in 2009, chiefly labor costs, insurance, property taxes and bank charges; (2) to correct a revenue shortfall which occurred when customers reduced usage after the 2009 filing; and (3) recover the cost of capital expenditures since the 2009 filing, including \$200,000 in DWSRF project costs funded by the Company and not included in the \$8.70/month surcharge approved in 2008, \$60,000 contributed directly by Company owner toward DWSRF projects, and a new vehicle replacing a1996 model.

The revenue impact of this filing, based on a 2013 test year, will be an annual increase of \$72,630, or 15.9% (approx. 3%/yr. over past 5 yrs.). The average customer bill would increase by \$7.97 per month. The revenue impact on each customer class affected is presented in an enclosed tabulation with supporting calculations, and is summarized as follows:

-	Flat Rate Service	\$4.84 (8.8%)
-	Metered Rate Service, 3/4 inch or smaller	\$7.97 (15.3%)
-	Metered Rate Service, 1 inch	\$8.76 (14.2%)
-	Ready-to-Serve Service	\$3.36 (13.8%)
