Frontier Communications Northwest Inc. files Advice No. 3345, a filing in the Exchange Maps WN U-7 Tariff, Section Maps.

Frontier Communications Northwest Inc. proposes to change the existing exchange boundary between the Arlington and Darrington serving areas, specifically in the Oso area. The exchange boundary will move west 9,250ft. Township 32N, Range 8E, Section 7 and Township 32N, Range 8E, Section 8 will then fall within the Darrington Exchange with this boundary change.

This change is necessary due to the Oso mudslide that took place on March 22, 2014. Prior to the mudslide, customers in this specific area were fed out of a remote site that linked back to the Arlington wire center. The mudslide destroyed Frontier's facilities in the area and since March these customers have been provided service temporarily from a remote site linked out of the Darrington wire center. Customers will not have to change their telephone numbers and they will be able to subscribe to DSL high speed broadband (DSL was unavailable to these particular customers while being provided service out of the Arlington wire center). There are twenty-seven impacted households but only seven active Frontier customers that would be affected by this boundary change.
