Re: Notice of cancellation of City Franchises and WUTC administrative oversight over collection of solid waste in the City of Spokane Valley by Waste Management of Washington, Inc., and Sunshine Disposal, Inc.

Dear Ms. Ingram:

On November 7, 2007, the Spokane Valley City Council approved a motion authorizing staff to notify the WUTC (pursuant to RCW 35.02.160) of the termination of the existing certificates under which Sunshine Disposal, Inc. (“Sunshine Disposal”) and Waste Management of Washington, Inc. (“Waste Management”) provided solid waste hauling services in the City of Spokane Valley (the “City”). In furtherance of that process, the City Council adopted replacement franchises with a term of seven years. Subsequently, the City amended the replacement franchises to have an effective date of March 10, 2008, terminating March 9, 2015. Under the replacement franchises, Sunshine Disposal and Waste Management continued to provide services continued to provide City customers the same services at the same rates as they provided to customers throughout the rest of their surrounding certificated areas.

Pursuant to RCW 81.77.020, the City provided notice to the WUTC of the termination of the haulers’ certificates and tariffs within the City of Spokane Valley. A copy of the replacement franchises and termination notice from 2008 is enclosed.

Since 2008, the City has entered into negotiations with both Waste Management and Sunshine Disposal for solid waste collection contracts to finally terminate their remaining rights pursuant to RCW 35.02.160.

On November 4, 2014, the City Council of the City voted to approve City contracts with Waste Management and Sunshine Disposal to replace the existing City franchises. The contracts are effective November 17, 2014. At that time, the City shall assume full control of all aspects of solid waste collection within its boundaries, including service levels, rate setting, and administrative oversight of the contracts and haulers. 

the adopted ordinances terminating the replacement franchises are enclosed. Copies of the executed solid waste contracts are available upon request.

While the City officially gave its notice to the WUTC in 2008, the City recognizes that pursuant to the City's franchises, there has existed a unique circumstance where WUTC continued to have apparent administrative oversight over Waste Management and Sunshine Disposal although such entities were operating pursuant to the City franchises. In consideration of the above, the City is providing this letter to give the WUTC notice of the City assuming full control over all aspects of solid waste collection within its jurisdiction. This letter is not new notice nor the first notice of such termination, as such notice was originally given in 2008. As of November 17, 2014, the City intends that the WUTC shall have no regulatory or administrative oversight over Waste Management or Sunshine Disposal within the boundaries of the City of Spokane Valley.


Dear Ms. Ingram:

On November 7, 2007, the Spokane Valley City Council approved a motion authorizing staff to notify the WUTC (pursuant to RCW 35.02.160) of the termination of the existing tariffs under which Sunshine Disposal and Waste Management provide solid waste hauling services in our city. In furtherance of that process, our Council adopted replacement franchises. Copies of the new franchises are included for your records. Under these replacement franchises, Sunshine and Waste Management will continue to have all the rights and obligations they currently have under the WUTC tariffs, for seven years.

In consideration of the above, please consider this letter a notice of termination of Certificate G-237, and Tariff No. 15 granted to Waste Management by WUTC, effective May 1, 2007, and Certificate G-199, and Tariff No. 7 granted to Sunshine Disposal by WUTC, effective September 1, 2006, to provide solid waste hauling within our city limits. The replacement status quo franchises shall be in effect as of March 10, 2008, with the WUTC continuing to provide regulatory oversight over both Sunshine and Waste Management. The replacement franchises shall expire on March 10, 2015, after which the City shall assume full regulatory control over solid waste collection.

WASHINGTON, GRANTING A SEVEN YEAR, NON-EXCLUSIVE FRANCHISE TO
SUNSHINE DISPOSAL, INC., TO PROVIDE GARBAGE AND REFUSE
COLLECTION SERVICE WITHIN THE CITY OF SPOKANE VALLEY**

WHEREAS, the City of Spokane Valley incorporated on March 31, 2003, at which time Sunshine Disposal, Inc., was providing garbage and refuse collection services in the geographic area comprising the new city;

WHEREAS, RCW 35.02.160 provides that when a new city incorporates, a company providing solid waste and refuse collection services within the new city shall be allowed to continue providing said services for at least seven years following the exercise of certain steps to terminate those statutory rights;

WHEREAS, the City Council has given preliminary approval to give notice of termination through the Washington Utilities and Transportation Commission; and

WHEREAS, the City desires to grant a status quo franchise to Sunshine Disposal, Inc., whereby Sunshine Disposal, Inc., shall be allowed to continue providing garbage and refuse collection services within the City of Spokane Valley under the same terms and conditions as has been previously allowed by the Washington Utilities Transportation Commission, and under which the Washington Utilities Transportation Commission would continue to have administrative oversight and control over the provision of these services.

NOW, THEREFORE, the City Council of the City of Spokane Valley, Spokane County, Washington, does ordain as follows:

Section 1. Grant of Franchise. The City of Spokane Valley, a Washington municipal corporation (hereinafter the "City"), hereby grants to Sunshine Disposal, Inc., D/B/A Sunshine Disposal & Recycling, (hereinafter "Sunshine"), a non-exclusive franchise for a period of seven (7) years, beginning on the effective date of this Ordinance, to provide garbage and refuse collection services in the City of Spokane Valley on identical terms and conditions as is set forth in Washington Utilities and Transportation Commission (WUTC) Certificate G-199, and Tariff No. 7 granted to Sunshine by WUTC, effective September 1, 2006, copies of which are attached to this franchise ordinance, and incorporated herein by reference. The WUTC will continue to provide administrative oversight and control over this franchise until this franchise expires or is superseded by a subsequent franchise.

AN ORDINANCE OF THE CITY OF SPOKANE VALLEY, SPOKANE COUNTY, WASHINGTON, TERMINATING THE SEVEN YEAR NON-EXCLUSIVE SOLID WASTE COLLECTION FRANCHISE GRANTED TO SUNSHINE DISPOSAL, INC., GRANTED PURSUANT TO ORDINANCE 07-022, AS AMENDED BY ORDINANCE 08-003, AND OTHER MATTERS RELATING THERETO.

WHEREAS, the City of Spokane Valley incorporated March 31, 2003, at which time Sunshine Disposal, Inc., (hereafter referred to as "Sunshine") was providing garbage, refuse, and recycling collection services in the geographic area comprising the new City; and

WHEREAS, RCW 35A.03.005 and RCW 35.02.160 provide that when a new city incorporates, a company providing solid waste and refuse collection services within the new city shall be allowed to continue providing said services for at least seven years following the exercise of certain steps to terminate the company's statutory rights; and

WHEREAS, on November 7, 2007, the City Council approved Ordinance 07-022 terminating Sunshine's statutory rights to provide solid waste collection services and granting a seven-year non-exclusive franchise to Sunshine to provide commercial and residential solid waste collection service within Spokane Valley. The City Council also gave approval to give notice of termination through the Washington Utilities and Transportation Commission; and

WHEREAS, on March 25, 2008, the City Council adopted Ordinance 08-003, amending Ordinance 07-022 and setting the effective date of the franchise granted to Sunshine as March 10, 2008; and

WHEREAS, the City has negotiated a solid waste collection contract and will enter into such contract with Sunshine concurrently with termination of the franchise granted pursuant to Ordinance 07-022, as amended by Ordinance No. 08-003, for Sunshine to continue providing commercial and residential solid waste collection services until March 31, 2018 in order to fully compensate Sunshine for all remaining measurable damages under RCW 35A.03.005 and RCW 35.02.160 and appellate decisions interpreting those statutory provisions; and

WHEREAS, the City Council hereby finds that termination of the franchise concurrently with the effective date of the new contract is appropriate.

NOW, THEREFORE, the City Council of the City of Spokane Valley ordains as follows:


Section 1. Termination of Franchise. The City Council hereby terminates the non-exclusive franchise the City granted to Sunshine pursuant to Ordinance 07-022, as amended by Ordinance 08-003, as of the effective date of this Ordinance. This termination is appropriate as the City and Sunshine have agreed to enter into a contract for Sunshine to continue providing commercial and residential solid waste collection services until March 31, 2018 in order to fully compensate Sunshine for all measurable damages under RCW 35A.03.005 and RCW 35.02.160, and appellate decisions interpreting those statutory provisions.

The City Manager, or designee, is hereby authorized and directed to provide any and all required notices to the Washington Utilities and Transportation Commission in conjunction with the termination of the franchise.

Section 2. Severability. If any section, sentence, clause or phrase of this Ordinance shall be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause, or phrase of this Ordinance.





WHEREAS, the City of Spokane Valley incorporated March 31, 2003, at which time Waste Management of Washington, Inc., d/b/a Waste Management of Spokane (hereafter "Waste Management") was providing garbage, refuse, and recycling collection services in the geographic area comprising the new City; and

WHEREAS, RCW 35A.03.005 and RCW 35.02.160 provide that when a new city incorporates, a company providing solid waste and refuse collection services within the new city shall be allowed to continue providing said services for at least seven years following the exercise of certain steps to terminate the company's statutory rights; and

WHEREAS, on November 7, 2007, the City Council approved Ordinance 07-023 terminating Waste Management's statutory rights to provide solid waste collection services and granting a seven-year non-exclusive franchise to Waste Management to provide commercial and residential solid waste collection service within Spokane Valley. The City Council also gave approval to give notice of termination through the Washington Utilities and Transportation Commission; and

WHEREAS, on March 25, 2008, the City Council adopted Ordinance 08-004, amending Ordinance 07-023 and setting the effective date of the franchise granted to Waste Management as March 10, 2008; and

WHEREAS, the City has negotiated a solid waste collection contract and will enter into such contract with Waste Management concurrently with termination of the franchise granted pursuant to Ordinance 07-023, as amended by Ordinance 08-004, for Waste Management to continue providing commercial and residential solid waste collection services until March 31, 2018 in order to fully compensate Waste Management for all remaining measurable damages under RCW 35A.03.005 and RCW 35.02.160 and appellate decisions interpreting those statutory provisions; and

WHEREAS, the City Council hereby finds that termination of the franchise concurrently with the effective date of the new contract is appropriate.

NOW, THEREFORE, the City Council of the City of Spokane Valley ordains as follows:

Section 1. **Termination of Franchise.** The City Council hereby terminates the non-exclusive franchise the City granted to Waste Management pursuant to Ordinance 07-023, as amended by Ordinance 08-004 as of the effective date of this Ordinance. This termination is appropriate as the City and Waste Management have agreed to enter into a contract for Waste Management to continue providing commercial and residential solid waste collection services until March 31, 2018 in order to fully compensate Waste Management for all measurable damages under RCW 35A.03.005 and RCW 35.02.160, and appellate decisions interpreting those statutory provisions.

The City Manager, or designee, is hereby authorized and directed to provide any and all required notices to the Washington Utilities and Transportation Commission in conjunction with the termination of the franchise.


