BACKGROUND

- 1 Charter and excursion carrier services operating in the state of Washington, subject to regulation by the Washington Utilities and Transportation Commission (Commission) must file and maintain proof of liability and property damage insurance (Form E).
- 2 On November 18, 2014, the Commission notified Lifestyle LLC, d/b/a Lifestyle Shuttles & Tours; Lifestyle Valet, (Lifestyle or Company) by letter that its certificate to operate as a charter and excursion carrier service in Washington would be cancelled if acceptable proof of insurance is not filed by December 29, 2014. The Commission also informed Lifestyle of its right to contest cancellation of the certificate by requesting a hearing within 10 days of the notice.

DISCUSSION

- The Commission has not received acceptable proof of insurance, and the Company has not requested a hearing. The Commission is authorized by WAC 480-30-171(2)(a) to cancel a charter and excursion carrier services certificate for failure to file and maintain proof of insurance. Certificate CH-65249 should be cancelled.
- To reinstate the certificate, Lifestyle would need to submit an application for reinstatement, pay the reinstatement fee, and file acceptable proof of insurance (Form E) within 30 days. After 30 days, the applicant will be subject to all terms and conditions of a new entrant.

FINDINGS AND CONCLUSION

- The Washington Utilities and Transportation Commission is an agency of the 5 (1)State of Washington having authority to regulate charter and excursion carrier services as defined in RCW 81.70.
- (2)Lifestyle is a charter and excursion carrier service operating in Washington 6 under certificate CH-65249.
- 7 On November 18, 2014, the Commission received notice of insurance (3) cancellation related to Lifestyle effective December 29, 2014. The Commission notified the Company that if a Form E insurance certificate was not received by the cancellation date, its certificate would be cancelled.
- The Commission is authorized by WAC 480-30-171(2)(a) to cancel a charter (4) 8 and excursion carrier services certificate for failure to file and maintain proof of insurance.
- 9 (5) The Commission should cancel Lifestyle's charter and excursion carrier services certificate for failure to file and maintain proof of insurance.

<u>ORDER</u>

THE COMMISSION ORDERS:

- Certificate CH-65249 held by Lifestyle LLC, d/b/a Lifestyle Shuttles & Tours; 10 (1)Lifestyle Valet, is cancelled as of December 29, 2014.
- (2) Lifestyle LLC, d/b/a Lifestyle Shuttles & Tours; Lifestyle Valet, is directed to 11 cease all operations associated with certificate CH-65249.
- 12 The Commission has delegated authority to the Secretary, or to the Secretary's delegate, to enter this Order under RCW 80.01.030, WAC 480-07-903(1)(c); and Order 04 in Docket A-090485.

The Commission will grant a late-filed request for review only on a showing of good cause, including a satisfactory explanation of why the person did not timely file the request. A form for late-filed requests is available on the Commission's Web site.
