BACKGROUND

- 1 Household goods carriers operating in the state of Washington, subject to regulation by the Washington Utilities and Transportation Commission (Commission) must file and maintain proof of liability and property damage insurance (Form E).
- 2 On December 18, 2014, the Commission notified Sno-King Moving Company LLC (Company) by letter that its permit to operate as a household goods carrier in Washington would be cancelled if acceptable proof of insurance is not filed by January 23, 2015. The Commission also informed Sno-King Moving Company LLC of its right to contest cancellation of the permit by requesting a hearing within 10 days of the notice.

DISCUSSION

- 3 The Commission has not received acceptable proof of insurance, and the Company has not requested a hearing. The Commission is authorized by WAC 480-15-450(1)(c) to cancel a household goods carrier’s permit for failure to file and maintain proof of insurance. Permit THG-65009 should be cancelled.
- 4 To reinstate the permit, Sno-King Moving Company LLC would need to submit an application for reinstatement, pay the reinstatement fee, and file acceptable proof of insurance (Form E) within 30 days. After 30 days, the applicant would be subject to all terms and conditions of a new entrant.

FINDINGS AND CONCLUSION

- 5 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington having authority to regulate household goods carriers as defined in RCW 81.80.
- 6 (2) Sno-King Moving Company LLC is a household goods carrier operating in Washington under permit THG-65009.
- 7 (3) On December 18, 2014, the Commission received notice of insurance cancellation related to Sno-King Moving Company LLC effective January 23, 2015. The Commission notified the Company that if a Form E insurance certificate was not received by the cancellation date, its permit would be cancelled.
- 8 (4) The Commission is authorized by WAC 480-15-450(1)(c) to cancel a household goods carrier's permit for failure to file and maintain proof of insurance.
- 9 (5) The Commission should cancel Sno-King Moving Company LLC's household goods carrier's permit for failure to file and maintain proof of insurance.

ORDER

THE COMMISSION ORDERS:

- 10 (1) Permit THG-65009 held by Sno-King Moving Company LLC is cancelled as of January 23, 2015.
- 11 (2) Sno-King Moving Company LLC is directed to **cease** all operations associated with permit THG-65009.
- 12 (3) The application for permanent household goods authority in Docket TV-131136 is dismissed.
- 13 The Commission has delegated authority to the Secretary, or to the Secretary's delegate, to enter this Order under RCW 80.01.030, WAC 480-07-903(1)(c); and Order 04 in Docket A-090485.

The Commission, at its discretion, may consider your request for review in an adjudicative proceeding under RCW 34.05 Part IV, or in a brief adjudicative proceeding under RCW 34.05.482 through .494. Following hearing, the administrative law judge will enter an initial order. If you wish to seek review of the initial order, you may file a petition for administrative review under RCW 34.05.464, or if the matter is heard in a brief adjudicative proceeding, under RCW 34.05.491.

The Commission will grant a late-filed request for review only on a showing of good cause, including a satisfactory explanation of why the person did not timely file the request. A form for late-filed requests is available on the Commission's Web site.

This notice and review process is pursuant to the provisions of RCW 80.01.030 and WAC 480-07-904(2) and (3), and WAC 480-07-905, as amended effective September 22, 2008.
