RESOLUTION NO. 2015-02

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ISSAQUAH, WASHINGTON, INDICATING THE INTENT TO CONTRACT FOR SOLID WASTE COLLECTION SERVICES IN ANNEXATION AREAS INDICATED HEREIN WITH REPUBLIC SERVICES, AND PROVIDING NOTIFICATION TO THE WASHINGTON UTILITIES AND TRANSPORTATION COMMISSION (WUTC) AND REPUBLIC SERVICES.

WHEREAS, the City Council of the City of Issaquah has approved an agreement with Rabanco Ltd d/b/a Allied Waste Services of Bellevue now known as Republic Services, for solid waste collection services, providing for collection services and orderly disposal of garbage, yard debris, and recyclable materials from residences and disposal of garbage from businesses; and

WHEREAS, the City Council has adopted Ordinances 2694, 2702, 2731, annexing property commonly known as McCarry Woods Annexation, Issaquah Middle School Annexation, and Lake Sammamish State Park Annexation; and

WHEREAS, RCW 35A.14.900 requires that the City Council formally indicate its intention to contract for solid waste collection services in the annexed areas as through ordinance or resolution,

WHEREAS, Republic Services has agreed to release all rights of collection in these areas, and waives all rights to damages or other compensation; NOW THEREFORE,

Section 1. Contract for Solid Waste Collection Services. Pursuant to RCW35A.14.900, the City of Issaquah hereby cancels the WUTC permit of Republic Services, operating under the certificate number G-12, for the McCarry Woods Annexation area, the Issaquah Middle School Annexation area, and the Lake Sammamish State Park Annexation area. Pursuant to the City's current agreement with Rabanco Ltd d/b/a Allied Waste Services of Bellevue, Republic Services has agreed to release all rights of collection in these areas and waives all rights to damages or other compensation under statute or provision of contract, and these areas will be covered under the City's contract authority currently served by Recology/CleanScapes.

Section 2. Effective Date. The effective date of this resolution shall be the February 1, 2015.

Section 3. Notification. Pursuant to RCW 35A.14.900, the City Clerk is hereby authorized and directed to file a copy of this resolution together with copies of the above indicated ordinances and annexation certificates with the Washington Utilities and Transportation Commission and Republic Services.

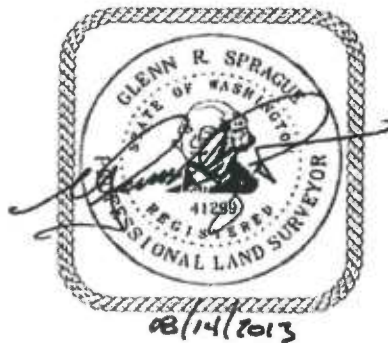
