# **BACKGROUND**

- 1 Household goods carriers operating in the state of Washington, subject to regulation by the Washington Utilities and Transportation Commission (Commission) must file and maintain proof of liability and property damage insurance (Form E).
- 2 On May 12, 2015, the Commission notified PMC Moving, LLC (Company) by letter that its permit to operate as a household goods carrier in Washington would be cancelled if acceptable proof of insurance is not filed by June 29, 2015. The Commission also informed PMC Moving, LLC of its right to contest cancellation of the permit by requesting a hearing within 10 days of the notice.

# **DISCUSSION**

- The Commission has not received acceptable proof of insurance, and the Company has not requested a hearing. The Commission is authorized by WAC 480-15-450(1)(c) to cancel a household goods carrier's permit for failure to file and maintain proof of insurance. Permit HG-64060 should be cancelled.
- To reinstate the permit, PMC Moving, LLC would need to submit an application for reinstatement, pay the reinstatement fee, and file acceptable proof of insurance (Form E) within 30 days. After 30 days, the applicant will be subject to all terms and conditions of a new entrant.

### FINDINGS AND CONCLUSION

- 5 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington having authority to regulate household goods carriers as defined in RCW 81.80.
- 6 (2) PMC Moving, LLC is a household goods carrier operating in Washington under permit HG-64060.
- 7 (3) On May 12, 2015, the Commission received notice of insurance cancellation related to PMC Moving, LLC effective June 29, 2015. The Commission notified the Company that if a Form E insurance certificate was not received by the cancellation date, its permit would be cancelled.
- 8 (4) The Commission is authorized by WAC 480-15-450(1)(c) to cancel a household goods carrier's permit for failure to file and maintain proof of insurance.
- 9 (5) The Commission should cancel PMC Moving, LLC's household goods carrier's permit for failure to file and maintain proof of insurance.

# <u>ORDER</u>

#### THE COMMISSION ORDERS:

- 10 (1) Permit HG-64060 held by PMC Moving, LLC is cancelled as of June 29, 2015.
- 11 (2) PMC Moving, LLC is directed to **cease** all operations associated with permit HG-64060.
- 12 The Commission has delegated authority to the Secretary, or to the Secretary's delegate, to enter this Order under RCW 80.01.030, WAC 480-07-903(1)(c); and Order 04 in Docket A-090485.

The Commission will grant a late-filed request for review only on a showing of good cause, including a satisfactory explanation of why the person did not timely file the request. A form for late-filed requests is available on the Commission's Web site.
