My name is Scott E. Conley I am a member of Scabland Taxi & Delivery, LLC. I am submitting this formal complaint concerning Nathan & Stacie Pack owners of Pack's Delivery, LLC. Nathan & Stacie received a WA State For Hire License and started Pack's Taxi & Delivery, LLC on April 25th, 2013. By February 2014 Nathan and Stacie had acquired a late model Dodge 14 passenger van which they began to advertise they would use to transport people to The Gorge Amphitheater for the concerts charging each person \$40 for round trip service. See attachment #1 and #2

On August 15, 2014 for the "Tom Petty Concert" the 14 passenger Dodge van is photographed at the Gorge Amphitheater campground entrance with a Pack's Taxi and Delivery Prius directly behind it. See attachment #3

In an August 26th 2014 Facebook post Nathan and Stacie are offering rides to the "Dave Mathews Concert" for \$45 round trip. See attachment #4

The current WA State license plate for the Dodge Van is AOW5561

By 2015 Nathan and Stacie had acquired another high capacity passenger van

The current WA State license plate of the Chevy van is AEM4148

Both vans do not have any (markings) letters or numbers on them this fact adds to the suspicion that Nathan and Stacie are utilizing these two vans to conduct an excursion service without the required commercial auto liability insurance and associated permits.

Just before the Concerts at the Gorge were set to begin again this year Nathan and Stacie in a May 29th 2015 Facebook post are again offering round trip service to the Gorge for \$45. See attachment #5

On June 9th 2015 a picture was taken of the two vans parked next to each other and next to a Pack's Taxi and Delivery cargo trailer. See attachment #6

We hope that Nathan & Stacie can be brought into compliance and that the two vans they are using will be properly insured and permitted to provide the type of excursion service they want to do.






