BACKGROUND

- Charter and excursion carrier services operating in the state of Washington, subject to regulation by the Washington Utilities and Transportation Commission (Commission) must file and maintain proof of liability and property damage insurance (Form E).
- On June 12, 2015, the Commission notified Triangle Charter Service LLC (Company) by letter that its certificate to operate as a charter and excursion carrier service in Washington would be cancelled if acceptable proof of insurance is not filed by August 25, 2015. The Commission also informed Triangle Charter Service LLC of its right to contest cancellation of the certificate by requesting a hearing within 10 days of the notice.

DISCUSSION

- The Commission has not received acceptable proof of insurance, and the Company has not requested a hearing. The Commission is authorized by WAC 480-30-171(2)(a) to cancel a charter and excursion carrier services certificate for failure to file and maintain proof of insurance. Certificate CH-362 should be cancelled.
- To reinstate the certificate, Triangle Charter Service LLC would need to submit an application for reinstatement, pay the reinstatement fee, and file acceptable proof of insurance (Form E) within 30 days. After 30 days, the applicant will be subject to all terms and conditions of a new entrant.

FINDINGS AND CONCLUSION

- 5 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington having authority to regulate charter and excursion carrier services as defined in RCW 81.70.
- 6 (2) Triangle Charter Service LLC is a charter and excursion carrier service operating in Washington under certificate CH-362.
- On June 12, 2015, the Commission received notice of insurance cancellation related to Triangle Charter Service LLC effective August 25, 2015. The Commission notified the Company that if a Form E insurance certificate was not received by the cancellation date, its certificate would be cancelled.
- 8 (4) The Commission is authorized by WAC 480-30-171(2)(a) to cancel a charter and excursion carrier services certificate for failure to file and maintain proof of insurance.
- 9 (5) The Commission should cancel Triangle Charter Service LLC's charter and excursion carrier services certificate for failure to file and maintain proof of insurance.

ORDER

THE COMMISSION ORDERS:

- 10 (1) Certificate CH-362 held by Triangle Charter Service LLC is cancelled as of August 25, 2015.
- 11 (2) Triangle Charter Service LLC is directed to **cease** all operations associated with certificate CH-362.
- The Commission has delegated authority to the Secretary, or to the Secretary's delegate, to enter this Order under RCW 80.01.030, WAC 480-07-903(1)(c); and Order 04 in Docket A-090485.
