### **BACKGROUND**

- Household goods carriers operating in the state of Washington, subject to regulation by the Washington Utilities and Transportation Commission (Commission) must file and maintain proof of liability and property damage insurance (Form E).
- On October 9, 2015, the Commission notified Speedy Delivery LLC, d/b/a Speedy Movers, (Speedy Movers or Company) by letter that its permit to operate as a household goods carrier in Washington would be cancelled if acceptable proof of insurance is not filed by November 8, 2015. The Commission also informed Speedy Movers of its right to contest cancellation of the permit by requesting a hearing within 10 days of the notice.

#### **DISCUSSION**

- The Commission has not received acceptable proof of insurance, and the Company has not requested a hearing. The Commission is authorized by WAC 480-15-450(1)(c) to cancel a household goods carrier's permit for failure to file and maintain proof of insurance. Permit HG-61514 should be cancelled.
- To reinstate the permit, Speedy Movers would need to submit an application for reinstatement, pay the reinstatement fee, and file acceptable proof of insurance (Form

E) within 30 days. After 30 days, the applicant will be subject to all terms and conditions of a new entrant.

#### FINDINGS AND CONCLUSION

- The Washington Utilities and Transportation Commission is an agency of the State of Washington having authority to regulate household goods carriers as defined in RCW 81.80.
- 6 (2) Speedy Movers is a household goods carrier operating in Washington under permit HG-61514.
- On October 9, 2015, the Commission received notice of insurance cancellation related to Speedy Movers effective November 8, 2015. The Commission notified the Company that if a Form E insurance certificate was not received by the cancellation date, its permit would be cancelled.
- 8 (4) The Commission is authorized by WAC 480-15-450(1)(c) to cancel a household goods carrier's permit for failure to file and maintain proof of insurance.
- 9 (5) The Commission should cancel Speedy Movers's household goods carrier's permit for failure to file and maintain proof of insurance.

#### **ORDER**

#### THE COMMISSION ORDERS:

- 10 (1) Permit HG-61514 held by Speedy Delivery LLC, d/b/a Speedy Movers, is cancelled as of November 8, 2015.
- 11 (2) Speedy Delivery LLC, d/b/a Speedy Movers, is directed to **cease** all operations associated with permit HG-61514.

The Commission has delegated authority to the Secretary, or to the Secretary's delegate, to enter this Order under RCW 80.01.030, WAC 480-07-903(1)(c); and Order 04 in Docket A-090485.

Following hearing, the administrative law judge will enter an initial order. If you wish to seek review of the initial order, you may file a petition for administrative review under RCW 34.05.464, or if the matter is heard in a brief adjudicative proceeding, under RCW 34.05.491.

The Commission will grant a late-filed request for review only on a showing of good cause, including a satisfactory explanation of why the person did not timely file the request. A form for late-filed requests is available on the Commission's Web site.

This notice and review process is pursuant to the provisions of RCW 80.01.030 and WAC 480-07-904(2) and (3), and WAC 480-07-905, as amended effective September 22, 2008.
