**BACKGROUND**

- 1 Motor freight carriers operating in the state of Washington, subject to regulation by the Washington Utilities and Transportation Commission (Commission) must file and maintain proof of liability and property damage insurance.
- 2 On November 18, 2015, the Commission notified Arturo Arroyo & Juan Estrada, d/b/a Dual Trucking LLLP, (Dual Trucking LLLP or Company) by letter that its permit to operate as a motor freight carrier in Washington would be cancelled if acceptable proof of insurance is not filed by December 20, 2015. The Commission also informed Dual Trucking LLLP of its right to contest cancellation of the permit by requesting a hearing within 10 days of the notice.

**DISCUSSION**

- 3 The Commission has not received proof of insurance, and the Company has not requested a hearing. The Commission is authorized by WAC 480-14-230(3)(d) to cancel a motor freight carrier's permit for failure to file and maintain proof of insurance. Permit CC-66043 should be cancelled. To reinstate the permit, Dual Trucking LLLP would need to submit an application for reinstatement, pay the reinstatement fee, and file acceptable proof of insurance (Form E).

**FINDINGS AND CONCLUSION**

- 4 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington having authority to regulate motor freight carriers as defined in RCW 81.80.
- 5 (2) Dual Trucking LLLP is a motor freight carrier operating in Washington under permit CC-66043.
- 6 (3) On November 18, 2015, the Commission received notice of insurance cancellation related to Dual Trucking LLLP effective December 20, 2015. The Commission notified the company that if a Form E insurance certificate was not received by the cancellation date, its permit would be cancelled.
- 7 (4) The Commission is authorized by WAC 480-14-230(3)(d) to cancel a motor freight carrier's permit for failure to file and maintain proof of insurance.
- 8 (5) The Commission should cancel Dual Trucking LLLP's motor freight carrier's permit for failure to file and maintain proof of insurance.

**ORDER**

**THE COMMISSION ORDERS:**

- 9 (1) Permit CC-66043 held by Arturo Arroyo & Juan Estrada, d/b/a Dual Trucking LLLP, is cancelled as of December 20, 2015.
- 10 (2) Arturo Arroyo & Juan Estrada, d/b/a Dual Trucking LLLP, is directed to **cease** all operations associated with permit CC-66043.
- 11 The Commission has delegated authority to the Secretary, or to the Secretary's delegate, to enter this Order under RCW 80.01.030, WAC 480-07-903(1)(c); and Order 04 in Docket A-090485.
