**NOTICE OF TRANSFER OF CUSTOMER BASE  
OF  
TELECOM NORTH AMERICA INC.  
TO  
G3 TELECOM USA INC.**

G3 Telecom USA Inc. (“G3 Telecom USA”), and Telecom North America, Inc. (“Telna”) hereby notify the Washington Utilities & Transportation Commission of a transaction between the two companies whereby the Washington interexchange long distance customer base of Telna will be transferred to G3 Telecom USA. This transaction is expected to take place on or after February 1, 2016, pending all regulatory approvals.

**I. DESCRIPTION OF TRANSFEREE AND TRANSFEROR**

**A. G3 Telecom USA Inc. - Transferee**

G3 Telecom USA Inc. was incorporated under the laws of the state of Delaware with principal offices located at 1039 McNicoll Avenue, Toronto, Ontario, Canada. G3 Telecom USA registered as a competitive telecommunications provider offering resold interexchange service within the state of Washington on March 23, 2011.

**B. Telecom North America Inc. - Transferor**

Telecom North America Inc. (“Telna”) is a privately held Corporation, incorporated under the laws of the State of Nevada on March 27, 2002 with principal offices at 2654 W. Horizon Ridge Parkway, Suite B5-143, Henderson, NV 89052-803. Telna is listed as a telecommunications provider (UT-091875) offering resold interexchange service within the state of Washington.

## **II. DESCRIPTION OF THE TRANSACTION**

G3 Telecom USA Inc. has entered into an agreement with Telecom North America, Inc. pursuant to which G3 Telecom USA will acquire the long distance telephone subscribers currently served by Telna via resale in Washington. After the date of the transfer, these services will be provided to the affected customers by G3 Telecom USA. The transfer of the customer base will take place no sooner than February 1, 2016, pending regulatory approvals.

## **III. CUSTOMER IMPACT**

Telna currently serves approximately 712 long distance subscribers in Washington who would be transferred to G3 Telecom USA as a result of the proposed transaction. Telna's customers have been notified of this transaction and have been informed that this transfer will not affect the current rates or the terms and conditions of the domestic services they subscribe to. A copy of the customer notice has been provided as Exhibit A.

### NOTICE OF CHANGE IN SERVICE PROVIDER

On February 1, 2016, G3 Telecom USA, Inc. ("G3") will become your new provider of long distance telecommunications services currently provided by Telecom of North America, Inc. d/b/a Telna ("Telna"), pending regulatory approval.

The transfer of the services to G3 will include a seamless transition that will not affect the current rates or the terms and conditions of your U.S. telecommunications services. Certain non-U.S. services currently provided by Telna will not be provided by G3 following the transfer, including:

- International Local Access Numbers
- International Toll-Free Services
- Telna Travel Card Services outside of North America

In the event of any future changes to the services, rates, or terms and conditions, G3 will notify affected customers pursuant to applicable state and federal rules and law.

You have a right to select a different preferred carrier for your long distance telecommunication services. G3 does not anticipate that this transition will cause you to incur any carrier change charges, but if you do, G3 will pay the carrier change charges associated with the transfer.

The services will be transferred to G3, even if you have arranged preferred carrier freezes through your local service providers on the services involved in the transfer, unless you select a different carrier before the transfer date. If you have a preferred carrier freeze on your account for long distance services, it will be lifted. You must contact G3 if you would like to arrange new preferred carrier freezes.

G3 will be responsible for handling complaints filed, or otherwise raised, prior to or during the transfer relative to both Telna and G3.
