The Federal Communications Commission has issued an Order (FCC Order No. 11-161)

that requires the Company to increase its rates to the levels set forth in this

Notice or face a corresponding reduction in its universal service support.

Universal service support enables the Company to provide high quality service to

you. The Company has historically opposed raising its local rates. However, the

Company believes it has no choice but to follow the FCC's requirement in order

to continue to receive universal service support at approximately the same level

it has in the past.
