Re: Request for Waiver from certain provisions of WAC 480-62-270

To Whom It May Concern:

Tacoma Rail respectfully requests Commission consideration of a rule waiver as allowed by Washington Administrative Code (WAC) 480-62-140, specifically from certain signage requirements at private road - railroad grade crossings prescribed in WAC 480-62-270 items (2)(a) and (2)(c).

As the Commission is aware, WAC 480-62-270 (2)(a) requires installation of a thirty-inch or larger R1-1 stop sign, and (2)(c) requires a rectangular sign, at least three hundred square inches in size, with the legend "Private Crossing" and the crossbuck symbol at private crossings through which any amount of crude oil is transported.

In an effort to achieve compliance with the Federal Railroad Administration's (FRA) Emergency Notification Systems (ENS) regulation, Tacoma Rail engaged in an effort to install standardized signage which includes crossbuck assemblies with yield signs (R1-2), reflective strips and ENS signs, consistent with current Manual of Uniform Traffic Control Devices (MUTCD) standards on all of the passive grade crossings both public and private throughout our maintenance territories.

Tacoma Rail seeks the UTC's consideration to allow us to keep in place the existing signage installed at private crossings over which crude oil is transported, rather than requiring Tacoma Rail to change the signs at those particular private crossings to include a stop sign and a rectangular sign as outlined in sections (2)(a) and (2)(c) of WAC 480-62-270.
