DECLARATION OF
RACHEL JONES

Rachel Jones, under penalty of perjury under the laws of the State of Washington, declares as follows:

1. I am employed by the Washington Utilities and Transportation Commission (Commission) as a Compliance Investigator in the Consumer Protection Section. As a Compliance Investigator, my responsibilities include conducting investigations regarding the business practices of regulated utility and transportation companies. As part of those duties, I investigate household goods carriers that may be operating without the required Commission permit.
2. On December 11, 2015, commission staff member began an investigation on Northwest Moving & Delivery Services who was allegedly operating as a non-permitted household goods carrier in Washington State. On December 14, 2015, a commission staff member sent a compliance letter to Ruben Escalera, who is documented as the owner of Northwest Moving & Delivery Services, requesting to cease and desist operations as a household goods carrier in Washington until a household goods permit is received.¹ On December 21, 2015, Mr. Escalera called and spoke with a commission staff member stating that he didn't know he needed a permit to perform household goods moves. He was asked to send an email acknowledging that he had received the compliance letter. On December 28, 2015, Mr. Escalera called commission staff member inquiring what he needed to do in order to become permitted. He was transferred to the Commission's Licensing Section. On January 5, 2016, Mr. Escalera sent commission staff member an email stating that he will stop operating as a household goods carrier until he has all the required permits and licenses.² I began an investigation into activities of Northwest Moving & Delivery Services in September 2016, after taking over the investigation from a former investigator with the Utilities and Transportation Commission.

3. On September 27, 2016, I called (509) 205-8159 under an assumed name and requested a quote for a residential move. A male answered the phone and identified himself as Ruben Escalera. Mr. Escalera stated that he was new to the moving business, but he had experience with moving furniture, so he knows how to take care of furniture and properly move it. He stated that he was trying to make a name for himself so he will be competitive. I told him I need help with a move from Marysville, WA to Pasco, WA, which is a four-hour drive. I told him that I'm moving from a three-bedroom apartment to a three-bedroom house in Pasco. Mr. Escalera told me that it would be too expensive to drive his truck down for the move, but I could rent a truck from U-Haul and he could get me a deal where it would only cost me \$150. Mr. Escalera stated that the move would cost me \$1,000, which included the full services of loading and unloading. Mr. Escalera stated that he wouldn't charge me by the hour due to wanting to be competitive since he is trying to get his name out. Mr. Escalera stated that it would take him six to eight hours and he would provide two movers. He also stated if I found someone with a better price he would match them.
4. On September 27, 2016, I started an internet search which produced an advertisement for Northwest Moving & Delivery Services on www.facebook.com and www.yellowpages.com.³
5. I reviewed Commission Records on September 27, 2016, related to Northwest Moving & Delivery Services to determine whether the company held a household goods permit. According to Commission records Ruben Escalera held a common carrier permit (CC067077), which was canceled on September 23, 2016, due to insufficient proof of insurance.⁴
6. On September 28, 2016, I completed a search on Washington Secretary of State and U.S. Department of Transportation Safety and Fitness Electronic Records (SAFER), which produced results of: Legal Name: Northwest Moving & Delivery Services LLC, physical and mailing addresses as 3612 W Agate St., Pasco, WA 99301, and US DOT number 2839687.⁵ A search of Washington Department of Licensing produced no results.⁶
7. On October 11, 2016, I sent a text to (509) 205-8159 requesting a quote for a move in Pasco, WA, from a three-bedroom apartment to a three-bedroom house in Pasco. I

received a response back stating it would be \$75 per hour for a truck, laborers, packing, and unloading.⁷

RE: Household Goods Moving in Washington State

Dear Mr. Escalera:

The Utilities and Transportation Commission has information that you are conducting household goods moves within the state of Washington. You do not have a valid permit, as required by state law, to conduct this type of work. Conducting household goods moves requires a permit issued by the commission.

To avoid enforcement action, your complete household goods permit application, supporting materials, and application fee must be submitted to the commission by **Dec. 28, 2015**.

Until you obtain a permit, you must immediately cease operating as a household goods mover in Washington state. Operating as a household goods mover without the required permit is illegal and subject to a penalty of **\$5,000 per violation**. This means that you may receive this penalty for each day you operate in violation of the law.

You must also immediately cease advertising as a household goods mover in Washington state. Advertising for the transportation of property for compensation in Washington without a proper permit is against the law. The penalty for advertising without a permit is **\$5,000 per violation**. This means that you may receive a penalty for each and every advertisement. At this time, the commission has documented advertisements for household goods moving services from Northwest Moving and Delivery Services.

If you advertise or operate as a household goods mover without a permit, the commission will take enforcement action against you. Such action will include the above-mentioned financial penalties; and you will be served with a subpoena and be required to appear before a judge.

Again, to avoid enforcement action, your complete application, supporting materials and application fee must be submitted to the commission by **Dec. 28, 2015**.

Should you decide to apply for a household goods moving permit, please note that you still may not operate as a household goods mover in Washington state until you have received a permit. To request a permit application, please call (360) 664-1222. You may also download an application from the commission's website at www.utc.wa.gov/mover.

Cancellation of Permit CC067077 Due To Insufficient Proof of Insurance

Dear Northwest Moving & Delivery Services LLC:

On August 23, 2016, the Washington Utilities and Transportation Commission (Commission) notified you that your transportation permit would be canceled unless you submitted acceptable proof of insurance by September 22, 2016. Our records show that you failed to submit acceptable proof of insurance by that deadline. As a consequence, **the Commission has CANCELED your permit. You must immediately CEASE all operations associated with this permit.**

You have the right to a hearing. If you believe the Commission should not have canceled your permit, you may ask the Commission to schedule a hearing before an administrative law judge. At the hearing the only issue the Commission will address is whether you had proof of insurance on file to avoid cancellation. Your request should be addressed to Steven V. King, Secretary, 1300 S. Evergreen Park Dr. SW, P.O. Box 47250, Olympia, WA 98504-7250. You may also email your request to records@utc.wa.gov. The Commission must receive your request within 14 days after the date of this letter.

You may apply to reinstate your permit. Download the reinstatement application at www.utc.wa.gov. To locate the application, go to Quick Links on the front page, select "Transportation Permit Applications" and the appropriate industry application.

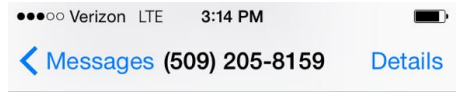

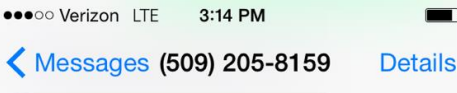

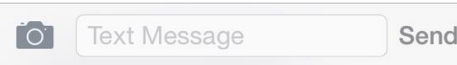
