## RE: Schedule G, Energy Efficiency Services and Programs – Residential and Commercial

Fourteenth Revision of Sheet G.1, Schedule G, "Energy Efficiency Services and Programs – Residential and Commerical."

The purpose of this filing is to add Rate Schedule 1 to the list of commercial schedules covered by the Company's Energy Efficiency Services and Programs. Rate Schedule 1 is a general sales service Rate Schedule available to all customer classes that qualify for this service.
