IX. Comments
Event Summary:
On October 2, 2017, at 5:06 p.m., Teodula Garcia Martinez was walking south on BNSF Railway main track one around milepost 115.64 when he was struck by southbound Amtrak locomotive #198. Video from the lead locomotive shows Mr. Martinez standing in the gauge of the railroad tracks facing east prior to and at the moment of impact. The video and a statement from the Amtrak engineer indicate Mr. Martinez made no effort to move from the tracks.
The Amtrak train was traveling south at 74 miles per hour when the engineer applied the emergency brakes. According to Amtrak engineer, he sounded the horn continuously until the train struck Mr. Martinez. The point of impact was determined to be 69 feet south of the Scott Avenue crossing. While searching for identification, officers turned on Martinez's phone and noticed music on the screen and they also found that he was in possession of headphones. The primary investigation was completed by the Woodland Police Department with assistance from the Cowlitz County Sheriff Department and the Amtrak Police. Mr. Martinez was examined by the Cowlitz County Coroner and it was determined that the cause of death was blunt force trauma from the impact with the locomotive. The Cowlitz County Coroner found contributing factors from alcohol, marijuana, and methamphetamine intoxication which is documented in the death certificate.
Site Description:
The location is 69 ft south of the Scott Avenue Crossing, USDOT 092437K. At the impact point the tracks are straight and without curves for a significant distance, at least 4000 feet. The location has steep ballast on the west side of main track 1. No trespassing/Danger signs are present near the crossing.  Inspector Recommendations:

### NARRATIVE / SUPPLEMENT:

On 10-02-17 at about 17:21 hours I, (Erik Swenningson, a City of Woodland Police Officer) was dispatched to a report of a train versus a pedestrian collision near the West Scott Avenue rail road crossing that had just occurred. The reporting party was Burlington Northern Santa Fe (BNSF) Railroad; they reported that a southbound Amtrak train struck a pedestrian on the railroad tracks and had employees out checking.

I was a few blocks away and arrived within a minute at the railroad crossing. I could see a southbound Amtrak train stopped several hundred feet to the south of the rail crossing. A female subject, later identified as Shari L. Sammeli (DOB: 11-12-1979) the conductor of the Amtrak train, was out walking along the tracks heading towards me. Sammeli appeared upset and told me she thought part of torso of the subject hit was near her on the west side of the railroad tracks.

I began walking south along the railroad tracks I began seeing blood spatter, clothing items and pieces of human tissue both inside the tracks and along the outside of the tracks on the west-side of the rail bed. I came to the area Sammeli had indicated next to the railroad bed and could clearly see the lower half of a human body wearing pants, but with no shoes or sox. I then noticed several feet away what appeared to be the upper half of the male subject still wearing part of a t-shirt. I advised dispatch by radio that due to the nature of the injuries apparent on scene the subject was clearly deceased and beyond medical help at this time. I requested dispatch contact BNSF and have them shut down all rail lines as we would be in the area walking along both sets of rail road tracks.

Officer Terry Casey arrived on scene and due to the nature of the incident requested dispatch notify the on-call Cowlitz County Coroner and Police Chief Kelly be advised of the incident. Officer Casey spoke with Sammeli and confirmed the engineer driving the train had seen only one subject on the railroad tracks at the time of the incident.

I obtained my department issued cell phone and started photographing the scene as Police Chief Kelly and Cowlitz County Sheriff's Office Sgt. Brightbill arrived on scene. Chief Kelly used crime scene tape to close off the area. I searched along the western most set of railroad tracks and found a small piece of tan cloth in the middle of the rails along with some scrape marks on the wood portion of the rail tracks. The piece of cloth appeared to be similar in color and type to that of the pants worn on the lower half of the subject. This piece of cloth was measured later to be about 69 feet south of the West Scott Avenue rail crossing and believed to be the initial point of impact between the Amtrak train and the subject, who was later identified as Teodulo Garcia Martinez (DOB: 05-29-1986), aka Ted Garcia.

Starting at what was believed to be the first point of impact, I began walking slowly along the railroad tracks photographing the entire scene and position of blood spatter, tissue, clothing items and the upper and lower portions of Garcia as they had been found on scene. (Photos saved on the Department's digital storage under this case number)

Officer Casey went and contacted the engineer (driver) of the Amtrak train, Karl C. Klontz (DOB: 1975). Officer Casey interviewed Klontz and informed me later that Garcia had been standing still on the railroad tracks facing east and did not move out of the path of the train even though Klontz was continuing to sound the trains' horn right up until the moment of impact. Klontz indicated to Officer Casey that it did not appear that Garcia recognized a train was approaching him until the last second just before impact. (See Officer Casey's supplemental report for additional details.) Officer Casey photographed the front section of the Amtrak train. On the front connector of the train, Officer Casey recovered a red hooded sweatshirt that had belonged to Garcia. Officer Casey found inside the pouch pocket of the red sweatshirt a 6 pack of children's' movies including Rugrats, Wild Thornberrys and Spongebob. There was no form of identification in the red sweatshirt, which was turned over to the Cowlitz County Coroners' Office when they arrived.

Officer Casey told me he spoke to a witness, Robert Wile, 1302 West Scott Avenue, Woodland, WA. Wile told Officer Casey he saw a Hispanic looking male subject in his 20's, wearing a red hooded sweatshirt and tan carhart work pants walking towards the train tracks while Wile had been outside mowing his lawn. According to Wile, Garcia had been walking east on West Scott Avenue from the direction of Guild Road. Wile had no interaction with Garcia.

Officer Robert Gibbs arrived on scene and together with Chief Kelly, we set up a baseline measurement parallel to the railroad tracks, starting at the piece of cloth I believed to have come from Garcia's pants to the last item we found to have come from Garcia, his left shoe. The total distance was 285 feet 8 inches. The following are measurements of significant items at the scene starting from a zero measurement:

- First blood spatter and tissue found 9 feet 10 inches inside the 1. railroad tracks
- Body part and tissue 44 feet 5 inches 2.
- 3. Garcia's hat found 44 feet 5 inches
- 4. Body impact with rail tracks 75 feet 1 inch
- 5. Right shoe found 80 feet 0 inches
- 6. A sock found 91 feet 8 inches
- A set of red headphones along with body tissue 120 feet 7 inches 7.
- 8. A leather belt 164 feet 2 inches
- A second sock 173 feet 8 inches 9.
- The lower half of the body and legs 207 feet 3 inches 10.
- The upper half of the torso 215 feet 3 inches The left shoe 285 feet 8 inches 11.
- 12.

Blood spatter marks and body tissues were found along the above measured path to the final point of rest of the upper and lower half of the body. Chief Kelly had taken the notes and performed a field diagram while taking the measurements. Chief Kelly said he would diagram the scene measurements using software for the case file (See attached diagram and Chief Kelly's report for more details.)

Cowlitz County Deputy Coroner Kristina Finn arrived on scene. I briefed her on what had been noted so far and she began taking photos for her report. Once she

had completed taking photos, with the help of Officer Casey they searched the lower half of Garcia's body for any identification. Officer Casey found a cell phone in the right rear pants pocket and handed it to me.

I photographed the front and back of the cell phone and then pressed the power button to see if the phone still worked, which it did. I noticed right away the screen of the phone displayed a rock song called, "Ego Brain," by System of a Down. The phone indicated the song was about half way through playing. I was able to access the phones functions and started searching the contacts list to see if the person had saved their own information or an emergency contact I noticed a contact saved as, "Me," with the name Ted Garcia listed.

Officer Casey and Coroner Finn had moved the upper half of the body from the bushes next to the railroad tracks up onto the gravel alongside the railroad tracks. At this point, we all noticed significant tattoos on the arms and side of Garcia's torso. Coroner Finn and I both photographed the tattoos. Looking at the face of the deceased subject, a tattoo on his neck and the name listed in the cell phone found in the pants pocket, I recalled the name Ted Garcia from a prior investigation. During the course of the investigation back in August of 2017, I had learned the subjects' name was actually Teodulo Garcia Martinez (DOB: 05-29-1986). I told Coroner Finn about this information to help aid her office in confirming the identity of the subject.

Coroner Finn, Officer Gibbs, Sgt. Brightbill and I helped place Garcia in the back of the Corner's van along with all of the clothing and personal items found at the scene, including the cell phone.

I spoke with Amtrak Police Detective Erik Vanderfange who had arrived on scene. Detective Vanderfange said he would provide me with details of the train's actions just prior to the moment of impact and images from the video footage taken by the camera at the front of the train.

On 10-04-17, while I was off-duty, I had received a voicemail message from Lamont and Maria D. Beverly (DOB: 1985). Maria said she was Garcia's sister and wanted to speak with me.

On 01-07-17, I received notification from the Cowlitz County Coroners' Office that the identity of the male subject hit by the train was confirmed to be Garcia.

On 10-07-17, I returned to work and called Lamont and Maria Beverly. According to Maria, Garcia had been back in Woodland, WA for about 2 weeks after leaving Beaverton, Oregon where the Beverly's live. According to Maria, Garcia was working off and on for various construction contractors in Cowlitz County for cash under the table to support himself.

Maria said Garcia believed he had a warrant for his arrest in Cowlitz County and he stated he was going to take care of the warrant by turning himself in. This is why Garcia was walking along the railroad tracks, to avoid being contacted by the police, said Maria. (Note I did not locate any warrants on Garcia at the time of his death).

Maria said Garcia's on-and-off girlfriend was Hope M. Fulkman, 717 Goerig Street, Woodland, WA. Fulkman has a young daughter that Garcia felt was like his step-daughter, said Maria. Garcia was on his way to Fulkman's home to visit. Fulkman's daughter had a birthday the following day on 4b and Garcia had purchased the children's movies to give them to her as a present,

said Maria.

Maria asked me if the death of her brother was being labeled a suicide. I told Maria that determination was not up to me and I had not heard that any determination had been made by the Coroners' Office at this time. Maria said she did not believe that her brother would commit suicide as he was afraid of death and had spoken with family members before about this fear.

On 10-10-17 I received information and photos from Detective Vanderfange. According to the information from Amtrak, the train was Southbound Amtrak Cascades # 507 with service from Seattle to Eugene, OR. The speed limit for passenger trains in the area of Woodland, WA is 79 MPH and the incident occurred at milepost 115.64. Detective Vanderfange said that the crossing gates and flashing lights of the rail crossing at West Scott Avenue were all working and active at the time.

The train had been operating at 79 MPH, but then reduced speed to 74 MPH and was operating at that speed when the emergency brakes were applied at 17:06 hours on 10-02-17. Detective Vanderfange confirmed that the train's horn was used prior to and during the crossing of West Scott Avenue. In Detective Vanderfange's review of the video of before and during the impact with Garcia, he notes Garcia was standing still in the middle of the railroad tracks and made no effort to move out of the path of the train.

Detective Vanderfange provided me with still images from the video taken by a camera mounted to the front of the Amtrak train. In the images I can see Garcia standing still in between the rails used by the southbound Amtrak train. Garcia is facing to the east and continues to face east until the moment of impact.

On 10-10-17, I contacted the Woodland Walmart Loss Prevention office and had them search through video from 10-02-17. Garcia came into the store at 16:21 hours and left after he made his purchases at 16:31 hours, he was last seen walking southeast through the parking lot towards Taco Bell, 1478 Dike Access Road, Woodland, WA.

All photos related to this investigation have been placed on the Department's digital storage drive.

The Cowlitz County Coroner's Office is conducting a toxicology test of samples taken from Garcia. The results of this test are still pending.

Nothing further at this time.

On 10.02.2017 at 1723 hrs, I (Officer Terry Casey) responded with Officer Erik Swenningson to a train versus pedestrian accident at the West Scott Ave railroad crossing in the city limits of Woodland Washington.

I arrived a few minutes later secondary to Officer Swenningson who had located and confirmed one deceased male subject. The subject was to the west of the southbound track, approximately 12 to 15 feet from the track. The trauma from the impact had torn the subject virtually in half at the waist line. Also standing by with Officer Swenningson was the Amtrak Conductor Shari Sammeli. I initially assisted Swenningson with locating pieces of evidence and attempting to find the point of impact. We were joined shortly thereafter by Chief Kelly and Cowlitz County Sheriff's Office Sargent Troy Brightbill. Chief Kelly took over as lead investigator.

I was directed to contact the train engineer, later identified as Karl Klontz. I drove along the access south to the Amtrak train. I first took photos of the front of the train. The deceased's red hooded sweatshirt was still wrapped in the front hoses next to the train coupler. I also took photos of the blood and body fluids pooled on top of the coupler. I then made contact with Karl Klontz. Klontz told me the subject was standing right in the middle of the southbound track facing east. Klontz sounds the loud engineer horn as a matter of routine due to the location being a street crossing. Klontz had continued to sound the horn with no breaks right up until impact. Klontz told me the subject made no attempt to move. Klontz further told me there would be video footage from the camera positioned at the front of the train.

I returned to the impact scene and checked the contents of the kangaroo pouch of the hooded sweatshirt. There was a 6 pack of DVD movies consisting of children's movies; Rugrats, Wild Thornberrys, Spongebob, etc etc. There was no identifying information in the sweatshirt.

I was then contacted by a neighboring resident Robert Wile. Wile lives at 1302 West Scott Ave. Wile asked if someone had been hit by a train. I confirmed there had, and Wile asked if he had been wearing a red sweatshirt and Carhart pants. I also confirmed this. Wile told me the male subject had just walked by his house while he was mowing his grass. The subject had been walking eastbound on West Scott Ave from the direction of Guild Rd. Wile told me the subject looked to be a Hispanic male in his 20s.

I then assisted Deputy Coroner Kristina Finn checking the two halves of the body for any identification. We did not locate any identification. However, I did locate a cell phone in the right side pocket of the pants. I handed the phone

up to Officer Swenningson. When we pulled the upper body from the edge of the blackberry bushes, I noticed distinct tattoos on either side of the subject's neck along with tattoos on both arms. Deputy Coroner Finn took photos of the tattoos.

This concluded my involvement in this investigation.

On October 2, 2017, at approximately 5:22 pm, an Amtrak train vs. pedestrian fatal collision occurred near West Scott Ave. in Woodland.

Woodland PD officers were notified of the collision by Cowlitz County Communications and responded to the scene. Officer Swenningson was the first officer on scene and reported that the pedestrian was deceased and asked the responding aid units disregard response. Officer Casey arrived at the scene and requested communications advise me of the incident. I arrived at the scene at 5:27 pm.

I contacted Swenningson and was informed of the location of the deceased and some of the evidence located so far. After a brief conversation with Swenningson I secured the scene with crime scene tape and spoke to one of the conductors who had been on the Amtrak at the time of the collision. She informed me the Amtrak Police Department would be responding to the scene. Swenningson and Casey located evidence and photographed the scene. I requested that Casey contact the train engineer and examine the train for evidence and collect it. Casey also photographed the front of the train.

Evidence present at the scene indicated the point of impact occurred on the west track of two tracks in the area. The point of impact was located 78 feet 10 inches south of the south side of the West Scott Ave crossing. Found at that location was body fluid spatter on the inside of the west rail. The evidence extended south approximately 285 feet. After impact the Amtrak was able to stop approximately 1684 feet south of the point of impact.

Officers Swenningson and Gibbs assisted me with mapping the scene. To map the scene a 300 foot baseline was used extending south from reference point one located 69 feet south of West Scott Ave. The baseline was established on the east outside of the east rail. Evidence was located taking 90 degree measurements off the baseline.

In the area of the collision the speed for Amtrak trains is 79 mph. Through this area the tracks are straight and level with no view obstructions. At the time of the collision all gates and warning signals were functioning properly. This was determined by BNSF personnel who arrived on scene during the investigation.

I cleared the scene at 7:22 pm.

On October 3, 2017, I used the measurements collected from the scene to generate a forensic map of the scene. This ended my involvement.


