Pursuant to WAC 480-109-110(1)(h) and condition (3)(e) in Appendix A of Order 01 in Docket UE-152058, (hereinafter referred to as "condition", or "requirements") Puget Sound Energy ("PSE") submits the attached conservation tariff sheet revisions. PSE requests that the Commission approve the revisions, and allow all to become effective January 1, 2018.

PSE updated the budgets and termination dates in electric and natural gas Schedule 83 and 183, (Conservation Service for electric and natural gas programs, respectively), and added language to each Schedule's Section 9: Special Conditions that provide enhanced access to measures for low-income customers. PSE also revised Schedule 201 (Low Income Weatherization) to allow funding provided by the Microsoft Special Contract.

PSE also proposes to change the name of its electric and natural gas Schedule 253: Resource Conservation Management. The new name, Resource Conservation Management (Energy Performance Incentive Programs), is more consistent with industry trends, and will provide for a greater range of related services. The revisions also bring the terms of the services up-to-date (for instance, modify the term "Resource Conservation Manager" to "Energy Manager").

¹ Sections A through J and Section L of the Electric Settlement Agreement, Docket UE-100177, and the 2001 Rate Case Stipulation Agreement, Exhibit F in Docket UG-011571 remain in effect. PSE reports compliance with these requirements in Exhibit 9: Condition Compliance Checklist.

Consistent with WAC 480-109-110(1)(h) and condition (3)(e), PSE reviewed the proposed Conservation tariff revisions with the CRAG on October 11, 2017. PSE received no comments or suggestions for revision changes.
