Dear Mr. King:

Pursuant to RCW 80.28.060 and Chapter 480-80 WAC, please find enclosed for filing the following proposed revisions to the WN U-60 tariff for electric service of Puget Sound Energy (“PSE”).

14th Revision of Sheet No. 129-A - Schedule 129 – Low Income Program (Continued)
Original Sheet No. 129-A.1 - Schedule 129 – Low Income Program (Continued)

The purpose of this filing and the natural gas tariff filing being submitted coincidentally is to revise the income eligibility criteria section of Schedule 129.

1. Clarification of the applicable income eligibility criteria prior to October 1, 2018. The added criterion is identical to the criterion that has been in effect since the inception of the Schedule 129 Low Income Program.
2. Revision of the implementation date of the new criteria from May 1, 2018, to October 1, 2018, at the request of the Schedule 129 Agencies to allow for the reconfiguration of their internal processes and systems. These new criteria were approved on December 5, 2017, by the Commission in Order 08, Final Order Rejecting Tariff Sheets; and Authorizing and Requiring Compliance Filing, in consolidated Dockets UE-170033 and UG-1700340.
3. Housekeeping changes to accommodate the space needed for the two income eligibility criteria applicable prior to and on and after October 1, 2018.

The tariff sheets described herein reflect an issue date of December 29, 2017, and an effective date of February 9, 2018. This filing will be published by posting the change on the PSE web site immediately prior to, or coincident with the date of this transmittal letter
