Re: Notification of Transfer of Indirect Control of GCI Communication Corp.

Dear Ms. Roth,

GCI Communication Corp. ("GCI"), a provider of telecommunication services in Washington classified by the Commission as a Competitive Provider, hereby notifies the Commission of the planned transfer of indirect control of GCI, in addition to other subsidiaries of General Communication, Inc. which are not regulated by the Commission. In the course of this transaction, General Communication, Inc., GCI's ultimate corporate parent, will be reconstituted with a new name, "GCI Liberty, Inc.," and the existing shareholders of Liberty Ventures Group will gain a controlling interest in this new corporate parent. Although Commission action is not required for this transaction, GCI submits this letter for informational purposes.

Because the transaction involves only the reorganization and change of majority ownership of GCI's ultimate corporate parent, the transaction is anticipated to have no material effect on GCI's operations in Washington. The transaction does not include any plans to alter the communications services that GCI provides. More information about the transaction can be found in the detailed public interest statement submitted to the Federal Communications Commission ("FCC").²
