SCENE INVESTIGATION REPORT

Section A: Scene Conditions

On January 16th, 2017, at approximately 0635 hours, The Chief Dispatcher of the Seattle Police Department Communications Section contacted me in the Traffic Collision Investigation Squad office regarding a train versus pedestrian collision that occurred inside the train tunnel north of King Street Station in the city of Seattle. After screening the incident with on-scene Acting Sergeant Rene Miller, I decided to initiate a TCIS

response. Detective Vincent Feuerstein and I drove to the north portal of the tunnel. A BNSF (Burlington Northern Santa Fe) employee transported us to the collision scene in a high-rail vehicle. The incident occurred near the center of the tunnel. Acting Sergeant Miller provided a synopsis of the incident: At approximately 0542 hours, a BNSF freight train was traveling northbound through the tunnel. The train crew noticed a pedestrian walking on the tracks. The engineer sounded audible warnings and activated emergency braking. As if a deliberate act, the pedestrian turned to face the train. The train failed to stop in time to avoid a collision. After the train came to a stop, the conductor rushed back to the pedestrian, who appeared unresponsive. Seattle Fire Department personnel responded and confirmed that the unidentified pedestrian was DOA. Detective Feuerstein and I took over the investigation.

The head end of the stopped train was facing northbound, just north on MP 0.2 on the Main One track. The as-of-yet unidentified man's body was lying under the train, between the rails, approximately 140 feet back from the head end of the train.

BNSF Tracks and Tunnel

At the time of the scene investigation, the "Great Northern" train tunnel, owned by Burlington Northern Santa Fe (BNSF) Railway, was comprised of two sets of tracks (Main One and Main Two) that ran the entire length of the 5500+ foot bore, from approximately South Jackson Street on the south to Pine Street on the north. The tunnel was approximately 30 feet wide with approximately eight feet separating Main One and Main Two tracks. Both entrances to the tunnel were fenced and gated, conspicuously posted with "No Trespassing" signs. Pedestrian traffic was forbidden within the railroad right-of-way, and no pedestrian accommodations were provided within the tunnel. The collision occurred on the Main One track, which was the western-most set of rails.

Section B: Train and Crew Information This incident involved the Seattle-to-Chicago "Z" train (highest priority). Consisting of four locomotives and 47 cars, the 4685-foot-long train weighed approximately 3249 tons.

The crew consisted of Engineer Jerome Graham and Conductor Derick Whitaker. Both members were riding in lead locomotive #6883. I interviewed the men. Graham said that the train was traveling through the tunnel at about 25 miles per hour when he spotted a pedestrian on the track about 200-400 feet ahead. Graham said that he sounded the horn and applied emergency braking. Whitaker said that he also saw the pedestrian. Both men said that the pedestrian did not move out of the path of the train. Instead, the pedestrian stood between the rails, faced the train, bent forward and flapped his arms "like a bird". Graham said that the train was unable to stop before hitting the pedestrian. After the train came to a stop, Whitaker disembarked and located the pedestrian's body under the train

about five cars back from the head end. Graham notified BNSF Dispatch of the incident.

Section C: Pedestrian Shoemacher, Justin D 11/4/80 345 16th Avenue #B Seattle, WA 98122

Members of the Seattle Police Department and Seattle Fire Department responded to the scene and noted obvious signs of death. The as-of-yet unidentified body was left in place. King County Medical Examiner's Office Investigator John Gallar came to the scene and conducted his investigation (18-0132). Gallar collected the body and transported it to his office. After positively identifying the decedent as Justin D Shoemacher, Gallar contacted next-of-kin. David Shoemacher, the decedent's father, phoned me at the office the day after the incident and provided some information about Justin's recent state of mind. David explained that Justin had recently moved out of his house following an argument with his wife. Justin had been living in a storage locker at an "art loft" facility located in the old Rainier Brewery on Airport Way South. David and his wife were concerned that Justin might have been feeling suicidal, so they flew to Seattle from Ohio in an effort to directly address their son.

Video footage recorded by the head-end of locomotive #6883 appeared to confirm that the pedestrian's actions were deliberate. The video included an audio track. As soon as the pedestrian appeared within the camera's field of view, the crew sounded the horn and applied the brakes. Several seconds elapsed, yet the pedestrian remained between the rails and faced the train. The pedestrian began waving his arms just before disappearing from view. BNSF retained the video file.

Approximately one hour and twenty minutes prior to the collision, another train crew reported seeing a suspicious person outside the north portal of the tunnel. The person, who was kneeling between the main tracks, was described as a white male wearing dark clothing. SPD officers were dispatched to the area, but did not locate the suspicious person (see SPD CAD 18-18646). It is possible that the person may have been Justin Shoemacher.

Section G: Collision Narrative

On the morning of January 16th, 2018, a Burlington Northern Santa Fe freight train was northbound on the Main One track of the Great Northern train tunnel north of King Street Station in Seattle. At approximately the same time, Justin Shoemacher, a pedestrian, was walking in the tunnel on the same track. Both portals of the tunnel were fenced, gated, and conspicuously posted with No Trespassing signs. The train crew spotted Shoemacher at approximately Milepost .2 and immediately sounded the train's horn. Shoemacher failed to move out of the train's path. Instead, Shoemacher faced the train and assumed an aggressive posture. Shoemacher was struck by the lead locomotive. The collision killed Shoemacher. An investigation conducted by the Seattle Police Department Traffic Collision Investigation Squad determined that the incident appeared to be a deliberate act.

Conclusion:

The proximate cause of this collision appeared to be Justin Shoemacher's intentional act of placing himself in the direct path of the approaching train in an area forbidden to pedestrians. The train crew did not appear to bear any responsibility in this incident. Detective Feuerstein concurred with my opinion.
