Re: Review Committee Decision - Case Numbers 18-003 and 18-004 Puget Sound Energy vs Estate Fence, LLC.

Dear Mr. King:

The Washington State Dig Law Safety Committee received a complaint regarding a potential violation of the Washington State Dig Law RCW 19.122.030(1)(a) for work performed on 10/25/2017 in case 18-003 and on 1/10/2018 in case 18-004.

On February 28, 2018, the Washington State Dig Law Safety Committee Review Board heard complaint Cases 18-003 and 18-004 Puget Sound Energy vs Estate Fence, LLC.

The Review Committee determined that the respondent, Estate Fence, LLC. did violate RCW 19.122.030(1)(a) on case 18-003 by failing to request locates 2 business days before digging for a fence. Estate Fence, LLC. did also violate RCW 19.122.030(1)(a) on case 18-004 by not requesting locates before digging for a fence.

The Review Committee recommends the following penalty be assessed to the respondent:

• Case 18-003, the committee decided to issue a warning and will send a warning letter to Estate Fence, LLC. No further action is required by the UTC for this case.

• Case 18-004 the committee recommends a fine of \$1000.00 with \$1000.00 deferred if the owner and field supervisors of Estate Fence, LLC. agree to complete NUCA dig safe training within 6 months of receipt of the UTC's penalty assessment letter and incur no additional dig law violations within 12 months.

History Summation:

Puget Sound Energy Damage Prevention Representatives have interacted with or observed work by Estate Fence 25 times. Out of the 25 experiences, they were found to be in violation of RCW 19.122 a total of 14 times. 13 times were related to not requesting a locate and the 14th time was for not maintaining marks.

We have contacted Byron Bese, the owner, and his Foreman Tim Butler, multiple times to educate them about the requirements of the dig law. We have also had interactions in the field with employees- Jason, Gene, and Mike Jacobsen. According to our documented history, we have been communicating with Estate Fence, since at least the fall of 2016. All 14 of the documented noncompliance events happened in 2017 and 2018.

Although we have documented 14 instances of noncompliance, our intent is to file on the 4 most recent as separate violations. Photos documenting noncompliance at each address follow the complaint summation.

Complaint #1- Location: 7030 30th Place W, Lot #14, Seattle- High Point Development Violation: RCW 19.122.030 (1)(a), Failure to call for Locates

Complaint #2- Location: 7030 30th Place W, Lot #13, Seattle- High Point Development Violation: RCW 19.122.030 (1)(a), Failure to call for Locates

Complaint #3- Location: 6968 Ave SW, Building #8, Seattle- High Point Development Violation: RCW 19.122.030 (1)(a), Failure to call for Locates

Complaint #4- Location : 410 6th Lane NE, Issaquah- Westridge Violation: RCW 19.122.030 (1)(a), Failure to call for Locates

Complaints 1-3, occurred on 10/25/2017 at the same development. PSE's Damage Prevention Field Rep Bob Douglas was working in the West Seattle area and observed recent fence construction in a new plat development at the addresses listed above. Upon inquiring with the site superintendent, Norm from Polygon Homes, he was told that the work was being done by Estate Fence Company. After checking <u>www.managetickets.com</u> Bob was able to determine that Estate Fence had not called in any locates within that development within the previous 60 days. He took photos, reminded the superintendent of Polygon homes that all sub-contractors must call for locates and left his card. He also left a voice message for Byron Bese. Byron did not return his call but did call for locates at these addresses the following day.




