



#### **RE: Charter and Excursion Carrier Services**

Dear Carmen Ceron-Garza:

The Washington Utilities and Transportation Commission (Commission) believes that you are providing passenger transportation services that require charter and excursion authority from the Commission. The purpose of this letter is to learn more about the passenger transportation services your company offers and to provide technical assistance with respect to Washington's passenger transportation licensing requirements.

As defined in WAC 480-30-036, one or more of the vehicles advertised and operated by your company requires a charter and excursion certificate from the Commission. Commission records show that you have not obtained the **required** certificate to operate as a charter and excursion carrier. Providing these services without a certificate is illegal, considered a gross misdemeanor, and punishable as defined in RCW 81.70.220 and WAC 480-30-246. Each violation of RCW 81.70.220 is subject to a penalty of up to five thousand dollars per violation.

## To avoid enforcement action by the Commission, no later than November 20, 2017, please do one of the following:

• Submit a completed application, file proof of insurance, and include the application fee to the Commission. For questions about the application process, please contact our Licensing Services staff at (360) 664-1222

• Explain in writing why you believe your business does not require passenger transportation authority from the Commission. Please explain the nature of your operations in detail. 
