**Re:** Review Committee Decision - Case Number 18-064 Hattenburg Excavating, Inc. vs Avista Corporation

Dear Mr. Johnson:

The Washington State Dig Law Safety Committee received a complaint regarding a potential violation of the Washington State Dig Law RCW 19.122.030(3)(b) for work performed on 6/9/2018.

On July 18, 2018 the Washington State Dig Law Safety Committee Review Board heard complaint Case 18-064 Hattenburg Excavating, Inc. vs Avista Corporation.

The Review Committee determined that the respondent, Avista Corporation, did violate RCW 19.122.030(3)(b) by failing to provide the excavator with available information as to the location of the facility operator's, identified but unlocatable underground facilities.

The Review Committee recommends the following penalty be assessed to the respondent: a \$1000.00 penalty, with \$1000.00 deferred for no additional violations of RCW 19.122.030(3)(b) for 12 months.

#### WA Complaint 18-064 Hattenburg Excavation vs Avista Avista Supporting Documentation July 18, 2018

#### SUMMARY OF INCIDENT:

The Location of the Locate Request – 29938 North Shore Drive, Loon Lake, WA (Attachment A Vicinity Map)

ELM, Avista's locating contractor, tried to locate the gas facilities for two locates tickets associated with the above referenced location.

Avista (NPL) submitted a locate ticket to relocate their facilities out of the way of a construction project at 39938 North Shore Drive in Loon Lake on 6/4/18. Several days later 6/6/18 Hattenburg Excavation submitted a locate ticket to demo the house at this property which part of the work included providing an open ditch for relocating Avista's facilities (which reduces the cost of the relocation). Avista's locators (ELM) tried for several days to locate the facilities, see timeline of events. There was a large portion of the pipeline at this location that would not locate, approximately 200 feet of service pipe and main. After several attempts to locate the facilities, Avista (Skyler project coordinator) ended up contacting another locating company to come GPR the line so that they could get the facilities relocated. The number of business days beyond Hattenburg Excavation's locate ticket start date and when the locate was finally completed was 2 business days on 6/12/18.

In conclusion Avista feels that they met the intent of 19.122.030 (3) (a-c) in regard to un-locatable facilities. Avista (Skyler and ELM) was in constant communication with both Hattenburg Excavation and Kyle Marsh Construction who hired Hattenburg. The best information available was communicated to them. The records research did not turn up any dimensional information to assist with determining the location of the pipeline. Avista attempted several times and with multiple locators to locate the facility. The locate was turned back to Avista who normally would send out an inspector to do some hand digging to try to find the facility; however, it was determined that the best course of action would be to hire another locating company with ground penetrating radar to try to locate the line.

#### TIMELINE OF EVENTS:

**6/4/18** (Mon) – NPL (Avista) requested a locate ticket, 18233160, for gas construction, Avista needed to relocate the existing gas facilities to 39938, 39929 and 39941 that are adjacent properties that are connected to the pipeline that runs to the main in the road. **(Attachment B)** 

**6/6/18** (Wed) - A locate ticket, 18238188 was called in by Hattenburg Excavation on 6/6/2018 to demolish a house at 39938 North Shore Rd Drive in Loon Lake, WA. The ticket description was to locate entire property and easements, area being marked in white. Work being done for Kyle Marsh. (Attachment C)

**6/6/18** – (NPL Ticket) Locator tried to locate gas pipeline and was unsuccessful before he was called away to meet a contractor on another ticket. Locator contacted Skyler (Avista) to let him know that he

was having problems locating the gas pipeline. Skyler said that they wouldn't be out until Monday to cut off the gas services. **(Locator Progression Comments, Attachment D)** 

**6/7/2018** (NPL Ticket) Locator completed electric locate for NPL ticket and made another attempt to locate the gas. **(Locator Progression Comments, Attachment D)** 

**6/8/2018 (Fri)** – (Hattenburg Ticket) The locator was able to locate one pole dip for electric, but gas services were un-locatable. The locator called the contact on the locate ticket, which was Marc Hattenburg and left a message letting him know that the service line was un-locatable. The locator also had ELM office contact Hattenburg by email at **11:46 am** on 6/8/18 that there was an un-locatable gas line. **(Locator Progression Comments, Attachment D) (Email to Hattenburg Excavation, Attachment E)** 

Locator did talk to contractor who said that they are digging on Monday to run power underground, Locator told them that pretty much most of the gas was un-locatable and not sure when a lead tech would be out to try to locate it and that Avista is supposed to be out Monday to relocate the gas services to the 3 houses. **(Locator Progression Comments, Attachment D)** 

**6/8/2018** – Locate ticket was transferred to lead locating tech who did a record research to see if there were any records that would provide more information such as dimensions to assist with locating the pipeline. The lead tech did not make it out to the site to troubleshoot the locate.


6/11/2018 (Mon) Lead Tech Locator notified contractor that all services are un-locatable. Main in front of these properties is also un-locatable. He marked where he could get a signal. (Locator Progression Comments, Attachment D) (Map of Un-locatable facilities, Attachment F)

**6/11/2018** – ELM/Sklyer decided to contact another locating company that has ground penetrating radar locating equipment. Skyler contacted AUUL about locating the pipelines.

6/12/2018 - AUUL located and marked the pipeline using ground penetrating radar equipment.

**6/14/2018** - Avista completed installation of new locatable facilities and de-energized the old piping that was in the way of the construction project. **(Attachment G)**







So we show with crew and equipment on site on Monday morning and still no locates so we had made a call to our gas representive from Avista Skylar Mayfield and told us he might be able to get a Avista gas crew there later in the week to expose the service line or told us that we could dig easy in the area of the of the non located part. I had then told Skylar that there is a \$ 2,500 a day fine for everyday not being located. Tuesday morning they did show up with this equipment and found all of the gas lines for us. Therefore Avista did not have it located in the 48 hours and give us any other information for us as required by law.
