The purpose of this filing is to adjust and true-up the low income rates as provided in the following:

- (1) Exhibit G to the Settlement Stipulation Agreement approved by the Commission in Docket Nos. UE-011570 and UG-011571 (the "Settlement"),
- (2) as provided in the Multiparty Settlement Stipulation in Docket No. U-072375 and the Partial Settlement in Docket Nos. UE-072300 and UG-072301,
- (3) as ordered by the Commission in Order 08 in Docket Nos. UE-111048 and UG-111049 ("Order 08")
- (4) as ordered by the Commission in Order 07 in Docket Nos. UE-121697 and UG-121705 (consolidated) issued jointly with Order 07 in Docket Nos. UE-130137 and UG-130138 (consolidated) ("Order 07")
- (5) as ordered by the Commission in Order 08 Docket Nos. UE-170033 and UG-170034.

The amount of change in the total electric revenue requirement over last year would be a decrease of \$465,525. This revenue requirement results in an approximate average overall decrease to rates for all electric customers of 0.02%. However, Schedules 10, 12, 26, 31, 35 and 43 would increase slightly and others would see no change. The typical residential customer on Schedule 7 using 900 kWh per month would experience a decrease of 3 cents per month or 0.03 percent. Details supporting the revised level of funding, revenue requirement and prior year collections are detailed in work papers provided with this filing.

The tariff sheets described herein reflect issue dates of August 31, 2018, and effective dates of October 4, 2018. Posting of the proposed tariff change for public inspection and review, as required by law and the Commission's rules and regulations, is being completed through web, telephone and mail access in accordance with WAC 480-100-193(1). Notice to the public under the provisions of WAC 480-100-194 will be provided, as required, within 30 days of the requested October 4, 2018, effective date.
