

Multiple citizens were out of their vehicles and pointing to the north side of the railroad track. I noticed that the train was stopped on the tracks across 52nd St E. One citizen yelled to me that he saw the person fly through the air. I climbed over the train and got on the north side of the tracks. I located a (V) black male wearing a bright blue shirt and bright blue short laying next to a concrete pillar. The male was face down but his pelvis was twisted around to be facing up, his head was pointing toward the northwest. I noticed blood on his head and his right ankle was snapped. I saw the male breathing so I advised South Sound 911 that he was breath and requested Fire personnel respond priority. I had a citizen grab my medical gloves from my marked patrol vehicle so I could render aid. I checked for a pulse but it was difficult because of the males body position. I talked to the male but never got a response. Fire personnel arrived on scene was took over rendering aid. Deputy Hoffman, #300, arrived on scene and I had him get his camera. I took a few digital photographs of the male prior to Fire personnel moving him. I contacted the train conductor (W) Quinn W. Yarger and train engineer (W) Anthony E. Hougland. They told me that the crossing arms were down and the warning lights were flashing, with sound warnings, at the 52nd St E crossing. They said they saw the male walking at a slow pace from north to south toward the tracks. They said they did not see the male wearing earphone. They said the male continued to walk on to the track, never looking toward the train. Deputy Hoffman collected the statements from the citizen witnesses. See Deputy Hoffman's Supplementary report for his actions and observation. Detectives arrived on scene and took over the investigation.


