The purpose of this filing is to add a new measure for electrical energy savings to Schedule 258 and the Large Power User/Self-Directed program. Energy-Efficiency Engineering Studies have been proposed to provide additional resources for eligible customers that did not or were not able to use their conservation rider allocations during the previous program cycle.

PSE provided draft tariff revisions in an email to its Conservation Resource Advisory Group ("CRAG") on January 25, 2019. PSE reviewed the new measure proposal with the CRAG during a webinar on February 8, 2019 and received the CRAG's endorsement.

The tariff sheets described herein reflect issue dates of February 25, 2019 and effective dates of April 1, 2019. Posting of the proposed tariff change for public inspection and review, as required by law and the Commission's rules and regulations, is being completed through web, telephone and mail access in accordance with WAC 480-100-193(1). Published notice is being completed under the provisions of WAC 480-100-195(3).
