Network Billing Systems, L.L.C. hereby notifies the Washington Utilities and Transportation Commission (“Commission”) that the Company is changing its name from Network Billing Systems, L.L.C. to **Fusion LLC**, effective April 1, 2019.<sup>1</sup> A copy of Fusion LLC’s Secretary of State name registration is attached.

The Company is registered as a competitive telecommunications service provider in the State of Washington.<sup>2</sup> The Company provides service exclusively to commercial subscribers. Subscribers are being notified of the name change via bill message. This change in corporate name will have no effect on the services offered to Washington subscribers.
