At about 1025CT A 517 1-26 (southbound) reported striking a bicyclist at F-Street in Bellingham, WA, MP 97.2. Crossing shows equipped with crossbucks, gates, bells, and flashers. There were no reported injuries to train crew or passengers. At 1108CT Bellingham police confirmed that the bicyclist was fatally injured.

1330CT A517 was released to head south.

1415CT Local police released tracks for normal operations.

- SYNOPSIS-

On 3-26-2019, at approximately 0824 hours, RICHARD LONSETH (V1) rode his bicycle from the west side of the BURLINGTON NORTHERN SANTA FE RAILROAD (R4) crossing at Roeder Ave and F St (Milepost 97.2/DOT #77846P) which has three sets of railroad track traversing the grade. RICHARD LONSETH (V1) rode onto the railroad tracks and directly into the path of a southbound Amtrak locomotive #90252 pulling passenger cars where he was struck and killed. Prior to the collision, RICHARD LONSETH (V1) had illegally entered the grade crossing because the crossing arms had been fully deployed/extended and the red crossing signals were flashing and the crossing bells were sounding on both sides of the crossing for nearly 30 seconds before RICHARD LONSETH (V1) rode into the path of the train. RICHARD LONSETH (V1) was struck and then rolled underneath the locomotive where he was drug about 256.8 feet up the train tracks before coming to rest between the rails underneath the lead axle of the locomotive.

-ON SCENE INVESTIGATION-

On 3-26-2019, at approximately 0825 hours, I was dispatched along with other officers to a bicyclist vs train collision at F St and Roeder Ave. I arrived at 0827 hours and found an Amtrak locomotive with eleven passenger cars and a rear locomotive. The train consist was stopped on the eastern most track and was completely blocking the grade crossing. The railroad crossing gates/arms were down, the crossing bells were sounding, and the red crossing signals were flashing.

I found the body of a deceased male, later identified by his Washington state ID card found in his wallet inside his pants, as RICHARD LONSETH (V1). RICHARD LONSETH (V1) was lying between the rails directly underneath the lead axle of the locomotive and mainly towards the right rail. He was lying with his left side towards the ground and his feet pointed towards the front of the locomotive in a southeastern direction. His left arm was extended up over his head and pointing towards the rear of the train in a northwestern direction. It was obvious by looking at the body that RICHARD LONSETH (V1) was deceased. Directly next to RICHARD LONSETH (V1), also between the rails, was a yellow 10-speed bicycle that was mangled and bent.

The area of Roeder Ave, F St, and W Holly St has been under construction for at least the past month. Today, the traffic signals at the intersections of Roeder Ave and F St and W Holly St and F St were placed on 4-way flashing red. Certified flaggers from COLACURCIO BROTHERS CONSTRUCTION (R2) were positioned on the west side of the crossing at Roeder St and F St and another flagger was positioned on the east side of the crossing at the white stop line about 15 feet from the railway. The two flaggers were controlling traffic flowing north and south on Roeder Ave and east and west on F St from W Holly St and onto Roeder Ave. Westbound traffic on F St, on the east side of the crossing, was narrowed down to one lane by the use of a COLACURCIO BROTHERS CONSTRUCTION (R2) flatbed truck, tall candlestick type delineators, and a large orange left arrow sign directing motorist to merge into the left lane of travel.

I talked to Officer Kaiser who had spoken to the flagger on the east side of the crossing, MCKENNA PINTO-GONZALEZ (W1). MCKENNA PINTO-GONZALEZ (W1) stated that she heard the crossing bells begin to sound and then saw that the crossing gates start to come down. At that time, MCKENNA PINTO-GONZALEZ (W1) turned her paddle to display "Stop" and subsequently stopped all westbound traffic on F St. She then

turned to coordinate with BRENDA FERRELL (W2) on the west side the crossing. She saw BRENDA FERRELL (W2) waving her stop sign/paddle and heard her yelling "stop" at somebody. MCKENNA PINTO-GONZALEZ (W1) then saw that the person she was yelling at was RICHARD LONSETH (V1) who was riding his his bike towards BRENDA FERRELL (W2). She continued to watch as RICHARD LONSETH (V1) rode past BRENDA FERRELL (W2) and onto the railroad tracks where he was struck by the train (see Officer Kaiser's follow-up report).

Traffic Officer Bruland finished the interview with MCKENNA PINTO-GONZALEZ (W1). Officer Bruland added that it didn't appear to MCKENNA PINTO-GONZALEZ (W1) that RICHARD LONSETH (V1) was aware of the approaching train until the split second prior to being struck where he quickly glanced to his left and then saw the train (see Traffic Officer Bruland's follow-up report).

Next, I spoke to Sgt Scanlon who had interviewed the other flagger, BRENDA FERRELL (W2), who was working on the west side of the crossing on Roeder Ave. BRENDA FERRELL (W2) told Sgt Scanlon that she saw RICHARD LONSETH (V1) riding his bike towards her from the north on Roeder Ave as he usually does almost daily. She then she saw that the crossing arms for the train tracks were down and it appeared to her that RICHARD LONSETH (V1) was riding in that direction towards the crossing. BRENDA FERRELL (W2) yelled at RICHARD LONSETH (V1) to stop but he rode past her and towards the railroad crossing. She continued to watch as RICHARD LONSETH (V1) rode his bike at about a 45 degree angle towards the train, entered the crossing, and crossed the tracks where he was struck by the train. BRENDA FERRELL (W2) said that RICHARD LONSETH (V1) got struck and was sucked under the train after impact. BRENDA FERRELL (W2) added that she clearly heard the train blowing their horn before the train collided into RICHARD LONSETH (V1) (see Sgt Scanlon's follow-up report).

Traffic Officer Stewart interviewed the train conductor, K MOTE and two Amtrak employees who said that they were standing outside on a platform facing the train tracks when the collision occurred (see Traffic Officer Stewart's follow-up report).

BURLINGTON NORTHERN SANTA FE RAILROAD (R4) Police Senior Special Agent DAN SARTAIN (C4) arrived on scene. DAN SARTAIN (C4) provided me with the train consist information and advised me that the train originated in Vancouver, British Columbia and was destined for Portland, Oregon with various stops along the way. The BURLINGTON NORTHERN SANTA FE RAILROAD (R4) train is a passenger train that is 537 feet in length and weighs 400 tons. The engineer of the train is CR Houser and the conductor is KELLY MOTE (W6).

BURLINGTON NORTHERN SANTA FE RAILROAD (R4) Police Detective STEVEN TRAVERS (C5) arrived on scene. He was transporting the replacement conductor and engineer for the train from Seattle so that the train could continue on to its destination after our investigation. STEVEN TRAVERS (C5) stated that he would be providing me with a written statement from the trains engineer, CR HOUSER, at a later date. He also stated that he would also secure the recorded video from the forward-facing video camera on the locomotive and we could arrange a time for me to view the video.

I was contacted by Officer B Johnson who told me that the traffic camera at W Holly St and F St recorded the incident. She then pulled up the traffic camera footage on her work iPhone and showed it to me. I could see that the crossing gates were down and that the red crossing lights were flashing on both sides of the crossing. A short time later, I could see that a bicyclist was riding southbound on Roeder Ave approaching F St. The bicyclist makes a left turn onto F St, and begins to ride at about a 45 degree angle across the train tracks. When the bicyclist begins to ride across the eastern most track he is struck by an Amtrak train traveling southbound. I asked Officer B Johnson to bookmark that recording so that it could be transferred later on to a storage device and added to this case file.

BFD Fire personnel removed RICHARD LONSETH (V1)'s body from underneath the train where it was transported to Dr Goldfogel's office by his staff. After the train continued on and the tracks were cleared I walked the entire length of the train tracks from the front locomotive to the grade crossing and marked items of evidentiary value and measured their distance to the point of impact (POI) with my Lidar instrument. The POI was determined to be just north of where two long scrape marks were found on the concrete in the eastbound lane of travel at the middle of the crossing. The scrape marks were left by the bicycle being drug by the train over the concrete surface. Following is a list of those items and corresponding distance:

CSI DeRuiter photographed the entire scene as well as the evidentiary items that were located (see his follow-up report).

Officer Yoder and Ofc Horton flew the UAV over the scene to collect video and photographs of the train consist as well as the railway once the train cleared the tracks (see their follow-ups).

-FOLLOW-UP INVESTIGATION-

I returned to the station and reviewed the traffic camera footage of the incident. The camera is mounted at the intersection of W Holly St and F St and is pointing in a southwesterly direction. The following is a timeline of events using the Avigilon recording systems time stamp:

- * 08:23.55 The crossing arms on both sides of the crossing begin to deploy downward and the red crossing signals on both sides begin to flash.
- \star 08:24.06 The crossing arms are fully down and blocking the two westbound lanes and one eastbound lane at the crossing.
- * 08:24.23 A bicyclist, RICHARD LONSETH (V1), appears about 28 seconds after the gates begin to deploy and the crossing lights begin to flash and approximately 17 seconds after the gates are fully down. RICHARD LONSETH (V1), wearing a black hoody style sweatshirt, with the hood pulled up over his head, and blue jeans is seen riding southbound on Roeder Ave approaching F St. RICHARD LONSETH (V1) is riding improperly using the oncoming northbound lane of travel and riding on the wrong side of the roadway against traffic. RICHARD LONSETH (V1) then turns left onto F St and rides his bike in the westbound lane as he approaches the train tracks. He then veers towards the right and begins to ride in about a 45 degree angle, in what looks like an attempt to cross the tracks and ride around the crossing gate arm

that is blocking the westbound lanes of travel on the east side of the crossing.

- * 0824.33.264 RICHARD LONSETH (V1) begins to ride across the most easterly set of train tracks and as he arrives at the tracks he glances towards his left and it appears that this is the first time he sees the train approaching him. It also appears that he prepares for impact as you can see his head duck down slightly and his shoulders hunch up just as he is about to be impacted by the train.
- * 0824.34.143 RICHARD LONSETH (V1) is impacted by the front locomotive of the train. RICHARD LONSETH (V1) falls forward and then appears to roll underneath the front of the locomotive, along with the bicycle he is riding, and then he disappears underneath the locomotive as it is traveling to a stop.

Later in the day, Traffic Officer Stewart obtained surveillance video footage from SANITARY SERVICE COMPANY (R1). We viewed the videos which showed two different camera positions from the west side of the crossing/intersection. The view is from the parking lot of SANITARY SERVICE COMPANY (R1) and pointing towards the northeast. It clearly shows RICHARD LONSETH (V1) riding his bicycle close to the curb of Roeder Ave using the northbound lane as he traveled southbound towards F St. He then makes a left turn onto F St and begins to ride diagonally between the two lowered crossing arm and the flashing red crossing signals. It appears that RICHARD LONSETH (V1) is attempting to ride around the lowered crossing arm on the east side of the railroad tracks and when then rides directly in front of the approaching train where he is struck.

-CONCLUSION-

Based on the statements of the witnesses, the surveillance video captured from the traffic camera and SANITARY SERVICE COMPANY (R1)'s cameras, RICHARD LONSETH (V1) improperly rode his bicycle in the wrong lane of travel and against traffic.He disregarded the verbal warnings by a flagger to stop as well as the 'Stop" sign/paddle that she was holding and waving at him. RICHARD LONSETH (V1) continued on and disregarded railroad crossing arms, flashing red warning signals and crossing bells and then illegally rode through a railroad crossing grade and onto the train tracks where he was struck by an approaching Amtrak passenger train. It appears that RICHARD LONSETH (V1)'s poor judgment and decision making as he rode his bicycle led to his peril.

At approx. 0825 hours, I was just clearing another collision when I heard of a train vs bicycle collision at F St and Roeder. Upon my arrival, I was contacted by a BNSF employee who stated he was trying to find the male. TO Bruland and I assisted and located the male, later identified as RICHARD LONSETH (V1), under the engine at the front of the train. I was advised that Medics were already in route but it was quite apparent that RICHARD LONSETH (V1) was deceased. TO Wright and Ortega were already en route and I requested Sgt Lanham and CSI's also respond.

As Medics arrived on scene, I then contacted 2 BNSF employees who advised that they had witnessed the event. I first spoke to JAMES DENSMORE (W4). JAMES DENSMORE (W4) advised that he had been standing with MARK FRASER (W5) on a BNSF wooden platform on the north side of the tracks just east of F Street. JAMES DENSMORE (W4) stated that he heard the Amtrak train approaching and heard it sound the horn multiple times as it approached F St. JAMES DENSMORE (W4) stated that he then observed the bicyclist (RICHARD LONSETH (V1)) begin to cross the tracks from the south. I asked JAMES DENSMORE (W4) if the crossing gates were down or not and he stated he wasn't sure as he was focused on the bicyclist. JAMES DENSMORE (W4) stated that he observed RICHARD LONSETH (V1) then get struck by the train. I asked if it appeared as though RICHARD LONSETH (V1) had stopped on the track or if he appeared to be riding across it when he was struck. JAMES DENSMORE (W4) was unsure and said it all happened so fast. He also pointed out MARK FRASER (W5) who he had been standing with on the platform and I spoke to him next.

MARK FRASER (W5) also advised that he had been on the platform watching as the Amtrak train approached. He also heard the train sound its horn multiple times as it approached F Street. As it crossed F St, he observed RICHARD LONSETH (V1) ride around the crossing arms that were down, and then watched as RICHARD LONSETH (V1) got "sucked under the train." MARK FRASER (W5) was a little more shaken up by the incident and advised he had respond to many scenes before and witnessed many people struck by trains by hadn't actually witnessed one being killed until today. I asked MARK FRASER (W5) if it appeared as though RICHARD LONSETH (V1) had stopped on the tracks in front of the train or if he appeared to be riding across it. All that MARK FRASER (W5) was sure of was that it appeared that RICHARD LONSETH (V1) was "on top of" his bicycle.

I then briefly spoke to KELLY MOTE (W6) who is the Amtrak train Conductor. KELLY MOTE (W6) stated that he had been a few cars back and had not actually witnessed the collision, however, he had also hear the train sound its horns multiple times as it approached F Street. The next thing KELLY MOTE (W6) new was that the train was in "full emergency braking." After getting off the train, he had already been in contact with the train's Engineer who he advised was pretty shaken up by the incident. I never spoke to the train Engineer as he was required to stay in his position in the Engine until he was relieved.

I then assisted with TO Ortega who was setting up the FARO scanner. We discussed several options for placement of the scanner, however. TO Ortega did all the scanning in this incident. I was also advised that there were 2 flaggers who were also on opposite sides of the train and were working the nearby construction zone on Roeder that had witnessed the incident. Both had advised that RICHARD LONSETH (V1) repeatedly ignored their flagging efforts and refused to obey them when told to stop. The most recent incident being approx. 20 minutes before the collision when RICHARD LONSETH (V1) crossed in the opposite direction, again ignoring the flaggers request to stop.

After clearing the scene, I got in contact with PAUL RAZORE (C2) the President of

SSC. I have contacted them before in reference to obtaining copies of their video camera surveillance of this intersection. PAUL RAZORE (C2) also advised that he was anticipating the call from us and already had the incident on a thumb drive for us. PAUL RAZORE (C2) then advised he would drop it off at the station. At approx. 1435 hours, I received the USB rive and viewed it on my computer. The video is from 2 different angles of the same intersection. Both clearly show the crossing arms lowering and the flaggers directing traffic along Roeder Ave. RICHARD LONSETH (V1) can be seen on the north side of Roeder Ave riding the wrong way and approaching F Street. RICHARD LONSETH (V1) can be seen ignoring the two crossing arms and red flashing lights and riding diagonally between them. As he is approx. half way across the train tracks, RICHARD LONSETH (V1) can be seen riding directly in front of the train and being struck by it. I have impounded this USB stick as evidence in this case.

On 03-26-2019 I was assigned to Patrol Division as a Uniformed Officer. At approximately 0825 hours, Officers were dispatched to a bicycle versus train at F Street and Roeder Avenue. Dispatch advised that multiple reporting parties had been transferred to the Fire Department.

When I arrived, I was flagged down by an employee from COLACURCIO BROTHERS CONSTRUCTION (R2) who identified herself as MCKENNA PINTO-GONZALEZ (W1). MCKENNA PINTO-GONZALEZ (W1) advised that she was working for COLACURCIO BROTHERS CONSTRUCTION (R2) as a flagger when she saw a male riding his bike toward the railroad crossing at Roeder Avenue and F Street. MCKENNA PINTO-GONZALEZ (W1) advised that she recognized the male as someone they have been having difficulty with while they have been at this job site. MCKENNA PINTO-GONZALEZ (W1) said that the male has been repeatedly disregarding COLACURCIO BROTHERS CONSTRUCTION (R2) flaggers instructions and directions.

MCKENNA PINTO-GONZALEZ (W1) advised that today, the railroad crossing arms were down and functioning at this time. MCKENNA PINTO-GONZALEZ (W1) said that she saw the other flagger, later identified as BRENDA FERRELL (W2), use her stop sign to attempt to stop the male. The male disregarded her efforts and continued riding through the railroad crossing. MCKENNA PINTO-GONZALEZ (W1) said that she observed the male make contact with the train.

- I talked with MCKENNA PINTO-GONZALEZ (W1) about getting a friend or family member to respond as support for her.
- I introduced MCKENNA PINTO-GONZALEZ (W1) to Traffic Officer Bruland for further conversation.
- I also spoke to another COLACURCIO BROTHERS CONSTRUCTION (R2), CATHY who oversees the flaggers. CATHY advised that she called on 03-15-2019 911 to report the male was disregarding flaggers. She advised that an Officer spoke to the male at that time. I was able to find case 19B14466 for further.

On 03-26-19, I responded along with several other units for a report of a "train vs bicyclist" accident. Upon my arrival I contacted BRENDA FERRELL (W2) who is a flagger for COLACURCIO BROTHERS CONSTRUCTION (R2) who is doing an extensive road repair job in the area, and has been for almost the last month.

I then asked BRENDA FERRELL (W2) if she was OK, and after she replied that she was, I then asked her to tell me what she had observed. She stated the following. She indicated that for as long as they have been on this job, they have had a problem with a guy they have named "yellow bike", and who today was identified as RICHARD LONSETH (V1).

BRENDA FERRELL (W2) stated that almost everyday, RICHARD LONSETH (V1) rides his bike through traffic, disregarding the flagger's and then either go through the intersection, or crosses the tracks, regardless if the arms are down or not. This happens so often that when someone sees him coming, they radio "here comes yellow bike" and they essentially shut down traffic so he doesn't get hit, even though he's not obeying the flagger's.

BRENDA FERRELL (W2) stated that today while flagging traffic, she saw RICHARD LONSETH (V1) coming from North to South on Roeder Ave, as always, disregarding traffic. She stated that she saw that the crossing arms for the train track were down, and it appeared that RICHARD LONSETH (V1) was heading in that direction. She watched as RICHARD LONSETH (V1) rode by her, at an oblique angle to the train and entered into the intersection that the train was about to cross, and she watched as he got struck and sucked under the train.

BRENDA FERRELL (W2) stated that she was yelling at RICHARD LONSETH (V1) to stop, and she clearly heard the train blowing their horn before the collision. When BRENDA FERRELL (W2) confirmed once again that she was OK, I advised her to call us back if she had anything further to add. She stated that she would do so.

Information that I learned from BRENDA FERRELL (W2) was then relayed to officers at the scene who were investigating the incident. Later this same morning I was asked to make NOK notification. It was learned that RICHARD LONSETH (V1) had a Guardian Ad Litem and that person was PETER NANSEN (R3) who is an attorney with an office last listed at 4160 Meridian #440. I responded to this location and saw that the whole fourth floor is rented out by Smith Gardens. They knew of no other tenants on said floor. I then called all the numbers associated with PETER NANSEN (R3) and found all of them to be out of order. I then called the house phone for PETER NANSEN (R3) and it too was no longer any good. I then called and left a message at the phone of Theresa Nansen, the wife of PETER NANSEN (R3) and asked that she call me back with some information on how I could get a hold of PETER NANSEN (R3) and why I needed to do so. I then asked that CA Sattarov look into his profile on line and try to find me a working number. Both numbers that she was able to locate were not to PETER NANSEN (R3).

It was later learned that all known family (Father, Mother & only brother) for RICHARD LONSETH (V1) have passed away. Unless something has been changed, PETER NANSEN (R3) is the only known person to be contacted and told about the death, given his legal position over RICHARD LONSETH (V1).

I responded to this bicycle v train collision at the F Street crossing and used my department issued Nikon D7100 camera for documentation.

Pictures 1 & 2 show the front end of this Amtrak train and capture the locomotives numbers. The crossing at F Street was still blocked by the following cars.

Pictures 3-5 show what was visible of the deceased, as seen in the gap between the front wheels and the front guard.

Pictures 6-9 show what was visible of the deceased and his bicycle, as seen between the first two wheels of the locomotive.

Pictures 10 & 11 show white paint that was used to mark the location of the front locomotive wheel.

Pictures 13-18 show what was visible of the deceased as seen from the opposite side of the locomotive.

After these photos I checked what was within reach of the deceased. I found a wallet in the front right pants pocket. The ID showed the individual as RICHARD LONSETH (V1).

Pictures 19 & 20 show that ID.

Pictures 21-24 show yellow paint transfer on a coupling at the very front of the locomotive. This transfer was thought to be from RICHARD LONSETH (V1)'s bicycle.

Pictures 25-27 show what appears to be a fresh gouge in the front guard.

Pictures 28-30 show a stocking cap that was found on top of a support for the front guard. The hat was later collected.

Pictures 31 & 32 are more images of the deceased as seen from the Roeder Street side of the train.

Pictures 33-39 show the F Street crossing as seen from the Roeder Street side.

Next, I documented items of evidence that were seen beneath the train. White spray paint had been used to mark railroad ties where evidence was seen.

Pictures 40-44 lead to a bicycle pedal that was seen close to the F Street crossing. This pedal was later collected.

Pictures 45-53 focus on what appeared to be fresh gouge marks in railroad ties between the tracks.

:Pictures 54-58 focus on what appeared to be jacket insulation.

Pictures 59-61 show the Holly Street side of the train and this side of the F Street crossing.

Pictures 62-66 show RICHARD LONSETH (V1) as he lay between the rails. After this I stood by while Fire Department personnel removed the body from under the locomotive.

Pictures 67 & 68 show LONSETH's bicycle. This was impounded.

Pictures 69 & 70 the the deceased's face, which appeared to match the WA ID found earlier in his pocket. CSI Vodopich and I attempted a MorphID scan of RICHARD LONSETH (V1)'s index fingers but there was no Hit return. Later, I ran a criminal history for RICHARD LONSETH (V1) and found he had only been booked once, in 2007.

During the investigation, I kept the Medical Examiner informed. He assumed jurisdiction and the body was removed by TRAVIS PARKE (C3).

Picture 71 was downloaded out of order. It shows RICHARD LONSETH (V1) bicycle just before it was impounded.

Pictures 72 & 73 show the tracks after the train left.

Pictures 74 & 75 show what appears to be a piece of sock. This was in the area where RICHARD LONSETH (V1) lay under the locomotive. This was not collected.

Pictures 76 & 77 show what appears to be a collar tag from the inside of a shirt. This was not collected, either.

Pictures 78-82 show body tissue that was found along the west or Roeder Street side of the tracks. This was presumed to be from a significiant injury to one of RICHARD LONSETH (V1)'s feet. This was later washed away by Bellingham Fire Department.

Pictures 83 & 84 show a glove, which was collected. LONSETH had a similar glove on one hand.

Pictures 85 & 86 show what appears to be a piece of jean material. This was collected.

Pictures 87 & 88 show what appears to be more jacket insulation wrapped around a spring. Several more similar springs were seen on the railroad ties. These turned out to be from the seat of LONSETH's bicycle. They were not collected.

Pictures 89-100 show what appear to be fresh gouge marks in various railroad ties.

Pictures 101 & 102 show the bike pedal, which was collected.

Pictures 103-110 show various marks to the pad of the F Street crossing.

Note that Officer Yoder and Horton used the UAS to document this scene as well. They flew low along the tracks after the train moved and captured images of the same items photodocumented above. The UAS footage should show distance relations between the various items and marks on the F Street pad.

No other photos were taken at the scene.

Pictures 111-113 show the contents of RICHARD LONSETH (V1)'s wallet. As seen in the photos, he had just over \$1400 in cash in his wallet.

Picture 114 shows the stocking cap from the front of the locomotive.

Picture 115 shows the bike pedal.
