Pursuant to RCW 80.28.060 and Chapter 480-80 WAC, please find enclosed for filing the following proposed revisions to the WN U-60, Tariff G for electric service of Puget Sound Energy ("PSE").

The purpose of this filing is to propose clarifying revisions to Schedules 551 and 552 tariff schedule sheets and Service Agreement attachments about PSE's electric vehicle charging products and services. Schedule 551 – Electric Vehicle Non-Residential Charging Products and Services provides for non-residential charging products and services, including public charging in public, workplace, and fleet settings. Schedule 552 – Electric Vehicle Residential Charging Products and Services focuses on single and multi-family residential customer response to load management.

The proposed revisions address the topics the Commission raised at the WUTC Open Meeting on December 13, 2018, and incorporate edits and other clarifications of tariff language and to create consistency among the three Service Agreements.

These changes include:

- Amending the Schedule 552 Service Agreement requirement of having two different agreements to distinguish the different need and requirement between a multiple-family EV charging Host and a Customer residing in a single-family home:
- Specifying the timeline of Customer notice of EV charging equipment repair timing;
- Outlining the timeline of Customer interaction near the end of a Service Agreement;
- Clarifying Customer's options at the end of a Service Agreement replacement, removal, or gifting;
- Specifying the default option at the expiration of a Service Agreement: and
- Listing of PSE-installed EV equipment at Customer/Host's site in an exhibit of a Service Agreement.

PSE thanks the Joint Utility Transportation Electrification Stakeholder Group, especially the staff of Washington Utilities and Transportation Commission and the Public Counsel Unit of the Attorney General's Office, for their input to these proposed tariff schedule revisions over the past several months.

The tariff sheets described herein reflect an issue date of May 10, 2019, and an effective date of June 14, 2019. These tariff changes do not increase recurring charges or restrict access to services. Notice of proposed tariff change, as required by law and the Commission's rules and regulations (including WAC 480-90-195(3)), is being given to the public immediately prior to, or coincident with, the date of this transmittal letter through web, telephone and mail access in accordance with WAC 480-90-193(1). Posting of the proposed tariff change, as required by WAC 480-90-193, is being made by posting the proposed tariff sheets on the PSE web site immediately prior to, or coincident with, the date of this transmittal letter.
