Note 1: <u>Permanent Service</u>: Service is defined as no less than scheduled, every other week pickup, unless local government requires more frequent service or unless putrescibles are involved. Customer will be charged for service requested, even if fewer containers are serviced on a particular trip. No credit will be given for partially filled containers.

Note 2: <u>Permanent Service</u>: If rent is shown, the rate for the first pickup and each additional pickup must be the same. If rent is not shown, it is to be included in the rate for the first pickup.

Note 3: Net Commodity Price Adjustment per Pickup will be a credit of $\leq 0.22 \geq (A)$ per yard. Customers whose service is less than one yard will receive a credit on a pro rata portion of a yard. Customers who have garbage collection services reflected in Items 255 and 275 will receive a credit of $\leq 0.66 \geq (A)$ per yard per pickup.

Note 4: Customers who have garbage collection services reflected in Items 240, 245 and 260 will be charged for recycling services at the rate of <u>\$1.23</u> per yard per pickup. Customers who have garbage collection services reflected in Items 255 and 275 will be charged for recycling services at the rate of <u>\$3.69</u> per yard per pickup.

Note 5: Effective September 1, 2017 can service will no longer be available to new customers. Existing can customers may continue to use their cans at the applicable tariff rates until such time that they choose to change their service. At such time, can customers will be required to subscribe for cart services provided for in the tariff.
