Dear Mr. Johnson:

Pursuant to RCW 80.28.060 and WAC 480-80-101 and WAC 480-80-105(1)(c), please find enclosed for filing the following proposed revision to the WN U-2 Tariff for natural gas service of Puget Sound Energy (“PSE”):

16th Revision of Sheet No. 1129 Schedule 129, Low Income Program

The purpose of this filing is to clarify in Schedule 129 the additional Schedule 129 Low Income Program benefit that is available to certain eligible customers who are receiving natural gas service under Schedule 23 Residential General Service but also elect the optional Schedule 171 Optional Non-Communicating Meter Service. This supplemental Low Income Program benefit covers the applicable Schedule 171 charges for qualified very-low-income customers. The Washington Utilities and Transportation Commission allowed the application of Schedule 129 funding toward certain customers’ Schedule 171 charges to become effective January 15, 2019, per the Utilities Agenda of January 10, 2019 under Docket UG-180861.

The revised tariff sheet regarding the electric Schedule 129 Low Income Program is also being filed concurrently under Advice No. 2019-27.

The tariff sheet described herein reflects an issue date of June 27, 2019, and effective date of July 27, 2019. Notice and Posting of proposed tariff changes, as required by law and the Commission’s rules and regulations, is being completed through web, telephone and mail access in accordance with WAC 480-90-193.
