Note 2: Recycling program charge (in addition to garbage rate) is \$5.07, and for recycling only service \$6.07 per month. Additionally, these customers will receive a commodity price adjustment (cpa) of \$1.92 (R) debit per month.

Note 3: Bi-weekly Yard Waste service is provided at an additional charge of \$5.53 per unit. Special pickup (not requiring dispatch) is \$3.80 per unit.
