- 1 **Synopsis:** The Commission seeks cancellation of the permits of household goods carriers that have failed to pay regulatory fees as required by RCW 81.80.321 and/or failed to file an annual report as required by RCW 81.04.080.
- 2 **Proceedings:** Household goods carriers holding a permit from the Washington Utilities and Transportation Commission (Commission) must file annual reports setting forth company operations during the preceding year. In addition, these household goods

carriers must pay annual regulatory fees to the Commission. Annual reports and regulatory fees are due on or before May 1.

- 3 Each year, in advance of this deadline, the Commission emails a link to the annual report form and instructions to all household goods carrier permit holders. Incorporated into the annual report form is a regulatory fee calculation schedule, which provides companies with step-by-step assistance in calculating their regulatory fees.
- 4 On March 16, 2019, the Commission emailed a notice containing a link to the annual report form and instructions to the email address on record with the Commission for each household goods carrier permit holder, including:

 - American Moving Co., Inc.
 - Arays Moving Service LLC
 - Backbreakers NW, LLC
 - Callbox Storage LLC
 - Five Stars Delivery LLC
 - Friends & Family Moving & Storage, Inc.
 - JFS Transport, Inc.
 - John Volken Academy
 - Johnson's Moving LLC
 - Alberto Moreno Mendoza
 - Jason M. Nelson
 - Pacific King Relocation & Logistics Systems LLC
 - PNW Moving and Delivery LLC
 - Property Pros Exterior Solutions LLC
 - Redefyne Moving LLC
 - Stanley G. Alexander, Inc.
 - We Like To Move It, Move It!! LLC

(collectively, the Companies). A search of Commission records indicates that each of the 19 Companies failed to file an annual report (or a complete annual report), remit a regulatory fee (if applicable), or both. Accordingly, Commission staff (Staff)¹ asks the

Commission to issue this Complaint seeking cancellation of each company's permit for violating the reporting and regulatory fee requirements of RCW 81.80.321, RCW 81.04.080, and WAC 480-15-480.

I. COMPLAINT

- 5 The Commission on its own motion, and through its Staff, alleges as follows:
- 6 Public service companies must file an annual report with the Commission. RCW 81.04.080.
- 7 Public service companies include every common carrier, and household goods carriers are common carriers. RCW 81.04.010.
- 8 Household goods carriers must remit to the Commission an annual regulatory fee of no more than one quarter of one percent of its gross income from intrastate operations for the previous calendar year. RCW 81.80.321.
- 9 The Commission is expressly empowered to issue rules and regulations governing household goods carriers. RCW 81.04.160.
- 10 The Commission emails a link to the household goods carrier annual report forms and instructions to each household goods carrier permit holder at its address on record with the Commission. If a carrier does not receive the link to the form, it is the carrier's responsibility to independently access the form online or contact the Commission and request the form. WAC 480-15-480.
- 11 Annual reports and regulatory fees are due no later than May 1 of the year following the year being reported. WAC 480-15-480.
- 12 The Commission may cancel a household goods carrier permit for good cause, including failure to submit an annual report or failure to pay regulatory fees. WAC 480-15-450.
- 13 Staff conducted its yearly compliance review of annual report and regulatory fee submissions for household goods carriers holding permits from the Commission. This review generated a list of companies that have failed to pay regulatory fees or failed to

submit annual reports (or complete annual reports). Those companies that still have not paid regulatory fees or filed annual reports (or complete annual reports) are named as respondents in this complaint.

- 14 A-1 Piano Sales & Rentals, Inc., (A-1 Piano) is a public service company as defined in RCW 81.04.010. A-1 Piano holds authority to transport household goods in the state of Washington for compensation. From the Commission's files and records, it appears that A-1 Piano failed to file the annual report due on May 1, 2019.
- 15 Alaska Coast Transport, Inc., (Alaska Coast) is a public service company as defined in RCW 81.04.010. Alaska Coast holds authority to transport household goods in the state of Washington for compensation. From the Commission's files and records, it appears that Alaska Coast failed to pay the regulatory fees and file the annual report due on May 1, 2019.
- 16 American Moving Co., Inc., (American Moving) is a public service company as defined in RCW 81.04.010. American Moving holds authority to transport household goods in the state of Washington for compensation. From the Commission's files and records, it appears that American Moving failed to pay the regulatory fees and file the annual report due on May 1, 2019.
- 17 Arays Moving Service, LLC, (Arays Moving) is a public service company as defined in RCW 81.04.010. Arays Moving holds authority to transport household goods in the state of Washington for compensation. From the Commission's files and records, it appears that Arays Moving failed to pay the regulatory fees and file the annual report due on May 1, 2019.
- Backbreakers NW, LLC, (Backbreakers) is a public service company as defined in RCW 81.04.010. Backbreakers holds authority to transport household goods in the state of Washington for compensation. From the Commission's files and records, it appears that Backbreakers failed to pay the regulatory fees and file the annual report due on May 1, 2019.
- Callbox Storage LLC (Callbox) is a public service company as defined in RCW
 81.04.010. Callbox holds authority to transport household goods in the state of
 Washington for compensation. From the Commission's files and records, it appears that
 Callbox failed to pay the regulatory fees and file the annual report due on May 1, 2019.

- 20 Five Stars Delivery LLC (Five Stars) is a public service company as defined in RCW 81.04.010. Five Stars holds authority to transport household goods in the state of Washington for compensation. From the Commission's files and records, it appears that Five Stars failed to pay the regulatory fees and file the annual report due on May 1, 2019.
- 21 Friends & Family Moving & Storage, Inc., (Friends & Family) is a public service company as defined in RCW 81.04.010. Friends & Family holds authority to transport household goods in the state of Washington for compensation. From the Commission's files and records, it appears that Friends & Family failed to pay the regulatory fees and file the annual report due on May 1, 2019.
- JFS Transport, Inc., (JFS) is a public service company as defined in RCW 81.04.010. JFS holds authority to transport household goods in the state of Washington for compensation. From the Commission's files and records, it appears that JFS failed to pay the regulatory fees and file the annual report due on May 1, 2019.
- John Volken Academy (Volken) is a public service company as defined in RCW
 81.04.010. Volken holds authority to transport household goods in the state of
 Washington for compensation. From the Commission's files and records, it appears that
 Volken failed to pay the regulatory fees and file the annual report due on May 1, 2019.
- 24 Johnson's Moving LLC (Johnson's Moving) is a public service company as defined in RCW 81.04.010. Johnson's Moving holds authority to transport household goods in the state of Washington for compensation. From the Commission's files and records, it appears that Johnson's Moving failed to pay the regulatory fees and file the annual report due on May 1, 2019.
- Alberto Moreno Mendoza (Mendoza) is a public service company as defined in RCW
 81.04.010. Mendoza holds authority to transport household goods in the state of
 Washington for compensation. From the Commission's files and records, it appears that
 Mendoza failed to pay the regulatory fees and file the annual report due on May 1, 2019.
- 26 Jason M. Nelson (Nelson) is a public service company as defined in RCW 81.04.010. Nelson holds authority to transport household goods in the state of Washington for compensation. From the Commission's files and records, it appears that Nelson failed to pay the regulatory fees and file the annual report due on May 1, 2019.
- 27 Pacific King Relocation & Logistics Systems LLC (Pacific) is a public service company as defined in RCW 81.04.010. Pacific holds authority to transport household goods in the

state of Washington for compensation. From the Commission's files and records, it appears that Pacific failed to pay the regulatory fees and file the annual report due on May 1, 2019.

- 28 PNW Moving and Deliver LLC (PNW) is a public service company as defined in RCW 81.04.010. PNW holds authority to transport household goods in the state of Washington for compensation. From the Commission's files and records, it appears that PNW failed to pay the regulatory fees and file the annual report due on May 1, 2019.
- 29 Property Pros Exterior Solutions (Property Pros) is a public service company as defined in RCW 81.04.010. Property Pros holds authority to transport household goods in the state of Washington for compensation. From the Commission's files and records, it appears that Property Pros failed to pay the regulatory fees and file the annual report due on May 1, 2019.
- Redefyne Moving, LLC (Redefyne), is a public service company as defined in RCW
 81.04.010. Redefyne holds authority to transport household goods in the state of
 Washington for compensation. From the Commission's files and records, it appears that
 Redefyne failed to pay the regulatory fees and file the annual report due on May 1, 2019.
- Stanley G. Alexander, Inc., (Alexander) is a public service company as defined in RCW
 81.04.010. Alexander holds authority to transport household goods in the state of
 Washington for compensation. From the Commission's files and records, it appears that
 Alexander failed to file the annual report due on May 1, 2019.
- 32 We Like to Move It, Move It!! LLC (We Like to Move It) is a public service company as defined in RCW 81.04.010. We Like to Move It holds authority to transport household goods in the state of Washington for compensation. From the Commission's files and records, it appears that We Like to Move It failed to pay the regulatory fees and file the annual report due on May 1, 2019.
- 33 In sum, the foregoing 19 Companies have failed to remit regulatory fees (if applicable) and file annual reports (or complete annual reports).

II. REQUEST FOR RELIEF

Staff asks the Commission to find that the Companies failed to comply with RCW
 81.80.321, RCW 81.04.080, and WAC 480-15-480 by failing to pay regulatory fees and file annual reports (or complete annual reports).

35 Staff requests that the Commission, pursuant to its authority in WAC 480-15-450, cancel the permits of the respondent household goods carriers.

III. PROBABLE CAUSE

36 Based on a review of Commission Staff's investigation report of Commission records pertaining to the submission of annual reports and regulatory fees by household goods carriers, and consistent with RCW 80.01.060 and WAC 480-07-307, the Commission finds probable cause exists to issue this Complaint.

IV. NOTICE OF HEARING

37 NOTICE IS HEREBY GIVEN that a hearing in this matter will be held on February 27, 2020, at 1:30 p.m., in the Commission's Richard Hemstad Hearing Room, 621 Woodland Square Loop SE, Lacey, Washington.

- 38 The Commission will hear this matter under the Administrative Procedure Act (APA), RCW chapter 34.05,² and pursuant to the Commission's procedural rules in WAC chapter 480-07.³ The Commission has jurisdiction over this matter pursuant to RCW chapters 80.01, 81.04, and 81.80,⁴ and under WAC 480-15.⁵
- 39 THE COMMISSION GIVES FURTHER NOTICE that any party who fails to attend or participate in the hearing set by this notice, or any other stage of this proceeding, may be held in default in accordance with RCW 34.05.440 and WAC 480-07-450.
- 40 If any party or witness needs an interpreter or other assistance, please fill out the form attached to this notice and return it to the Commission.
