Re: Notification Regarding the Change in Name of Securus Technologies, Inc. to Securus Technologies, LLC

Dear Mr. Johnson:

By this letter, Securus Technologies, Inc. ("Securus, Inc.") notifies the Commission of the change in name of Securus, Inc. to Securus Technologies, LLC ("Securus, LLC"), which became effective at the end of the day on December 31, 2019. Securus, Inc. is authorized to provide competitive telecommunications services in Washington pursuant to Docket UT-001208.

Securus, Inc. was originally incorporated as a State of Delaware corporation. Pursuant to Title 6, Section 18-214 of the Delaware Code, it has converted to Securus, LLC. Under that provision of Delaware law, there is no dissolution or termination of the converting business entity. No new legal entity is created and there is no legal transfer of assets or Securus, Inc.'s Washington authorization as a result of the conversion – they remain with the same legal entity.¹

Following the conversion, Securus, LLC continues to offer and/or provide the same services as the corporate entity offered prior to the conversion. There are no changes in the rates for or the nature or extent of services for customers as a result of the conversion. Further, there is no change in management or ownership of the company as part of the conversion. Securus, LLC continues to be located at 4000 International Parkway, Carrollton, TX 75007.

Attached as Exhibit 1 is a copy of the Washington Secretary of State Application for Transfer of Foreign Entity Registration on Merger or Conversion filed on January 14, 2020.
