ER	ER Title	Description 2020
2204	Substation Rebuilds	This program replaces and/or rebuilds existing substations as they reach the end of their useful lives or where installed equipment that fails or is being replaced for capacity needs cannot be accommodated within the physical constraints of the small, older stations.
2586	Washington AMI	This project will replace existing metering systems in Washington State with an advanced meter reading system. The replacement will install an AMI metering system that will include: meters, network, back off systems, and data repository.
3008	Aldyl-A Pipe Replacement	The Company is continuing a 20-year program to systematically remove and replace select portions of the Aldyl-A medium density polyethylene pipe in its natural gas distribution system in the States of Oregon, Washington, and Idaho. None of the subject pipe is "high pressure main pipe," but rather, consists of distribution mains at maximum operating pressures of 60 psi and pipe diameters ranging from 1½ to 4 inches.
3311	Cheney HP Reinforcement	This project will increase the capacity of the gas system in Cheney, WA. The current system does not have the capacity to serve all firm customers on a design day. This project will also add an appropriate amount of capacity to the system to support further growth of new and existing customers.
6110	Cabinet Gorge Fish Passage	The Clark Fork Settlement Agreement and License require Avista to implement a Native Salmonid Restoration Plan, which contemplates a step-wise approach to investigating, designing and implementing fish passage at the Clark Fork Project.
