Pursuant to RCW 80.28.060 and WAC 480-80-101 and WAC 480-80-105(1)(c), please find enclosed for filing the following proposed revisions to the WN U-2 Tariff for natural gas service of Puget Sound Energy (“PSE”):

4th Revision of Sheet No. 21-C Rules and Regulations (Continued) Rule No. 9 Bills and Payment for Service (Continued)

The purpose of this tariff revision is to allow PSE to not charge its Late Payment Fee in certain situations, consistent with its discretion regarding the disconnection of service. To allow PSE to be immediately responsive to the rapidly changing economic conditions facing customers in the wake of the spreading COVID-19 virus, PSE respectfully requests that the Commission allow these tariff changes to become effective on March 13, 2020 with less than statutory notice (“LSN”). The information required by WAC 480-80-122 Tariff Changes with Less Than Statutory Notice, is contained in the attached LSN form.

The tariff sheet described herein reflects an issue date of March 10, 2020, and effective date of April 10, 2020. Posting of proposed tariff changes, as required by law and the Commission’s rules and regulations, is being completed through web, telephone and mail access in accordance with WAC 480-90-193.
