Dear Commercial Customer,

This is to notify you of a proposed rate change for commercial waste services in the Towns of Twisp and Winthrop, WA and portions of Okanogan County where Methow Valley Sanitation Service, Inc. d.b.a. WasteWise Methow (the Company) operates. Should the Washington Utilities and Transportation Commission (the Commission) approve this case, customers will experience a rate increase throughout all classes of service effective June 1, 2020.

It has been six years since the Company's last general rate case. In that time the Company has absorbed cost increases in key areas including workforce and maintenance. In addition, it is necessary at this time for the Company to replace key equipment to ensure the safest, most reliable service possible. The Commission has the authority to set final rates that may be either lower or higher than proposed, depending on the results of its investigation. Commission staff will make a recommendation to the Commissioners at an open meeting at Commission Headquarters, 1st Floor Hearing Room, 621 Woodland Square Loop SE Lacey, Washington, at 9:30 a.m. on May 21, 2020. You have the opportunity to comment at this meeting. The Commission is committed to providing reasonable accommodation to participants with disabilities.
