NOTICE OF PENALTIES INCURRED AND DUE FOR VIOLATIONS OF LAWS AND RULES

The Washington Utilities and Transportation Commission (Commission) believes that Terra Underground, LLC, (Terra Underground or Company) has violated Revised Code of Washington (RCW) 19.122.055 by failing to request a dig ticket prior to excavation and subsequently damaging an underground natural gas facility. RCW 19.122.055 states, in part, that any excavator who fails to notify a one-number locator service before excavating and causes damage to a hazardous liquid or gas facility is subject to a civil penalty of not more than \$10,000 for each violation.

Commission staff (Staff) conducted an investigation that included reviewing damage reports submitted by Avista Corporation (Avista) that identified a natural gas damage event involving Terra Underground. Accordingly, the Commission hereby notifies you that it is assessing a penalty of \$5,000 against Terra Underground on the following grounds:

On August 29, 2018, the Commission assessed a \$1,000 penalty against the Company in Docket DG-180699. On May 13, 2019, the Commission assessed a \$3,000 penalty against Terra Underground in Docket DG-190244. Both of these penalties were for violations of RCW 19.122 that occurred because Terra Underground damaged underground natural gas facilities without providing the notice required to facility operators before excavating.

On December 10, 2019, Terra Underground was excavating at 2710 S Morrill Ln., Spokane, Washington. While excavating, Terra Underground workers struck and damaged an underground Avista gas facility. The Damage Information Reporting Tool report submitted by Avista on January 7, 2020, indicated that Terra Underground was excavating without a valid request to locate underground utilities. Staff's investigation of this damage incident determined that Terra Underground did not have a valid dig ticket for the excavation that resulted in the damage incident.

Staff recommends the Commission assess a \$5,000 penalty against Terra Underground for one violation of RCW 19.122.055 for failing to provide the required notice to a one-

number locator service before excavating and causing damage to an underground natural gas facility for the violation that occurred on December 10, 2019.

Staff's research indicates that Terra Underground has submitted 37 requests to locate underground utilities in Washington during 2019. The violation appears to be the result of the Company's negligence rather than a lack of knowledge of the requirements of Washington's dig law.

The Commission agrees with Staff's recommendation and assesses a penalty of \$5,000.

These facts, if not contested or if proved at a hearing and not rebutted or explained, are sufficient to support the penalty assessment.

Your penalty is due and payable now. If you believe the violation did not occur, you may deny committing the violation and contest the penalty through evidence presented at a hearing or in writing. Or, if there is a reason for the violation that you believe should excuse you from the penalty, you may ask for mitigation (reduction) of the penalty through evidence presented at a hearing or in writing. The Commission will grant a request for hearing only if material issues of law or fact require consideration of evidence and resolution in a hearing. Any request to contest the violation or for mitigation of the penalty must include a written statement of the reasons supporting that request. Failure to provide such a statement will result in denial of the request. *See* RCW 81.04.405.

If you properly present your request for a hearing and the Commission grants that request, the Commission will review the evidence supporting your dispute of the violation or application for mitigation in a Brief Adjudicative Proceeding before an administrative law judge. The administrative law judge will consider the evidence and will notify you of their decision.

You must act within 15 days after receiving this notice to do one of the following:

- Pay the \$5,000 penalty amount due; or
- Request a hearing to contest the occurrence of the violation; or
- Request mitigation to reduce the amount of the penalty.

Please indicate your selection on the enclosed form and send it to the Washington Utilities and Transportation Commission, P.O. Box 47250, Olympia, Washington 98504-7250, **within FIFTEEN (15) days** after you receive this notice.

If you do not act within 15 days, the Commission may refer this matter to the Office of the Attorney General for collection. The Commission may then sue you to collect the penalty.
