Notification of Change in Direct Control of Desert Winds Wireless LLC

Dear Secretary Johnson,

This letter serves as the notification of a planned transfer of control of Desert Winds Wireless LLC d/b/a/ Internet Xpress (the "Company"), a registered competitively classified telecommunications carrier in the State of Washington. The Company is currently wholly owned by Dustin DeCoria ("Transferor") and will be transferred into the control of EV Holdings 1 LLC, a Delaware Limited Liability Corporation (the "Transferee") (jointly the "Parties") through a Stock Purchase Agreement (the "Transaction").

For background, EV Holdings 1 LLC is a Delaware Limited Liability Corporation. EV Holdings LLC is a wholly owned subsidiary of Rural Wireless LLC, a Nevada Limited Liability Corporation. Rural Wireless LLC is a wholly owned subsidiary of Enduring Ventures Inc., a Delaware Benefit Corporation. EV Holdings 1 LLC is a holding company and does not provide telecommunications services or hold any Commission authorizations.

The Stock Purchase Agreement was executed on June 24, 2020 with a target closing date for the transaction set as July 3rd, 2020. The Parties will notify the Commission after successful close that the transaction has been completed.

The transaction will affect only the ultimate ownership of the Company, and will not result in any changes in rates, terms, customer service offerings, billing practices, or conditions of service for retail customers. The Parties are not seeking to cancel or assign any licenses or rights through this transaction. The transaction will have no immediate effect on the operations of the Company, and Transferor will remain engaged with the Company for a minimum of 6 months following the Transaction. This transfer of control will have no adverse effect on Washington Customers, and the Company will continue to offer and/or provide the same services as offered prior to the transaction. In no event will the transaction result in the discontinuance, reduction, loss, or impairment of service to customers

As per WAC 480-121-063, we believe the Regulatory Requirements for Transfer of Property (RCW 80.12.020) are waived in this context, therefore the Parties should not require prior approval for this transaction. If this is incorrect, please notify us immediately


