Re: Review Committee Decision – Case 20-028 Cassidy Stevenson vs. Liberty Fence, LLC

Dear Mr. Johnson:

The Washington State Dig Law Safety Committee received a complaint regarding a potential violation of Washington State Dig Law RCW 19.122.030 for work performed on June 25, 2020.

On, August 11, 2020, the committee formed a review board and heard Case 20-028 filed by Cassidy Stevenson against Liberty Fence, LLC.

The review board determined that the respondent, Liberty Fence, LLC., violated RCW 19.122.030(2) for failing to request a locate before excavation.

Therefore, the committee recommends a total penalty of \$1000.00 is assessed to the respondent as follow:

Case 20-028 \$1000.00 penalty for one violation of RCW 19.122.030(2)

The recommended penalty totals \$1000.00, with the possibility of \$800.00 deferred on the condition that Jeremy Whitney attends NUCA dig safe training and Liberty Fence, LLC. incur no additional violations of RCW 19.122 within twelve months of receiving a penalty assessment order.
