## **APPLICATION TO RATE SCHEDULES:**

Each year, in accordance with the terms agreed to in the Company's Energy Efficiency Plan, Sales Service rates for the Rate Schedules listed below will be adjusted on an equal cents per margin basis, to recover the actual costs of energy conservation programs incurred – these costs are reflected in the column labeled Schedule G Current Year Costs. Adjustments to Current Year Costs rates shall be made coincident with the Company's annual Purchased Gas Adjustment (PGA) filing, or at such other time as the Commission may authorize. In addition, in accordance with Order 06 in Docket UG-181053, an October 31, 2019, deferral balance of incurred conservation program costs will be amortized over four years beginning November 1, 2019 – these costs are reflected in the column labeled Schedule G Historical Balance.
