Pursuant to RCW 80.28.060 and Chapter 480-80 WAC, please find enclosed for filing the following proposed revision to the WN U-2, tariff for natural gas service of Puget Sound Energy ("PSE"):

## 11<sup>th</sup> Revision of Sheet No. 42 - Rule No. 28: Income Tax Rider-Contributions in Aid of Construction

The purpose of this filing is to update certain tariff rates that were impacted by Order 08, Final Order Rejecting Tariff Sheets; Authorizing and Requiring Compliance Filing ("the Order") in consolidated Dockets UE-190529 and UG-190530.

The revised tariff Sheet No. 42 sets forth the proposed rates in Rule No. 28: Income Tax Rider-Contributions in Aid of Construction to reflect the overall rate of return and capital structure approved in the Order. A revised tariff sheet regarding the electric service Schedule 87, Income Tax Rider-Contributions in Aid of Construction, is being filed concurrently under Advice No. 2020-32.

The tariff sheet described herein reflects an issue date of October 1, 2020, and an effective date of November 1, 2020. Posting of the proposed tariff change for public inspection and review, as required by law and the Commission's rules and regulations, is being completed in accordance with WAC 480-90-193(1). No additional public notice is required under the provisions of WAC 480-90-194 or -195. A customer will receive an individual notice through the quoted price prior to incurring the Rule No. 28 charge.
