Kayla,

If you aren't operating and won't be for a while, what we will have to do is process this as a voluntary permit cancellation. We cannot suspend a HHG permit, but we can voluntarily cancel, which will allow you to cancel insurance. When you're ready to operate again, you can apply to reinstate and would get the same permit number. If the cancellation is COVID related, there is an existing order that waives reinstatement fees so long as you apply within 90 days of the entire state hitting phase 4. Before I proceed with cancelling your permit, can you confirm if this is in any way COVID related?
