**NOTICE OF RESOURCE ADEQUACY MEETING
AS REQUIRED BY RCW 19.280.065
(To be held Tuesday, May 11, 2021, at 9 a.m.)**

Re: In the Matter of Annual Resource Adequacy Meeting, RCW 19.280.065,
Docket UE-210096

TO ALL INTERESTED PERSONS:

Pursuant to RCW 19.280.065, the Washington Utilities and Transportation Commission (UTC) and the Washington Department of Commerce (Commerce) are holding a meeting to discuss resource adequacy from 9 am to 3 pm on Tuesday, May 11, 2021. The discussion is the first of annual meetings required by RCW 19.280.065.

[RCW 19.280.065](#) requires the UTC and Commerce hold a meeting to discuss issues related to resource adequacy and to provide a summary of the meeting to the governor and legislature as follows,

(1) At least once every twelve months, the department and the commission shall jointly convene a meeting of representatives of the investor-owned utilities and consumer-owned utilities, regional planning organizations, transmission operators, and other stakeholders to discuss the current, short-term, and long-term adequacy of energy resources to serve the state's electric needs, and address specific steps the utilities can take to coordinate planning in light of the significant changes to the Northwest's power system including, but not limited to, technological developments, retirements of legacy baseload power generation resources, and changes in laws and regulations affecting power supply options. The department and commission shall provide a summary of these meetings, including any specific action items, to the governor and legislature within sixty days of the meeting. (2) This section expires January 1, 2025.

This meeting will be conducted entirely in a virtual format. An agenda will be posted by 5 pm, Friday May 7, 2021.
