Dear C&N Enterprises Inc.:

The following items need to be completed and/or corrected for prompt processing of your application for operating authority. Please complete and return to our office by March 18, 2021. You may not operate until these issues are resolved and you have received your approved permit.

- We cannot approve a permit with the trade name “A Team Moving and Storage” because there is already an “ATeam Moving LLC” operating with permit number THG069163 in Washington state. Those names are too similar. WAC 480-15-390 outlines Commission responsibilities regarding trade names. Your options are:
 - Obtain written permission from ATeam Moving LLC for use of the name within Washington.
 - Select a new trade name to operate under within Washington. Please contact the following agencies to add your trade names:
 - Business Licensing Services/Department of Revenue - 1-800-451-7985 or www.bls.dor.wa.gov
 - Federal Motor Carrier Safety Administration - www.fmcsa.dot.gov/registration or 360-753-9875
- The Labor and Industries - Worker's Compensation Account number is missing. You must have this account number before we can issue authority. Call L&I at 1-800-987-0145 or visit <http://www.lni.wa.gov/ClaimsIns/Insurance/Learn/Open/Default.asp>.
- Your company will need to apply and receive an Employment Security registration number. The Employment Security Department can be reached at 360-902-9396 or visit <https://www.esd.wa.gov/> for information.

- You submitted an out-of-date application. Please complete the current form that is included in this email and return to patrick.remfrey@utc.wa.gov. You do not need to replace any of the other information that you previously submitted.
- You are required to attend commission-sponsored training prior to receiving your provisional permit. We have signed you up for training on February 17, 2021. The training will be conducted virtually. Please contact Emily Duke at emily.duke@utc.wa.gov to reschedule if you cannot attend the above-noted training.
- Request a Uniform Motor Carrier Certificate of Insurance (Form E) and proof of Cargo Insurance (Form H) from your insurance company. **The insurance must show your legal name, and the Washington Utilities and Transportation Commission (WUTC) must be shown as the certificate holder.** Please ask your insurance company to email the insurance to transportation@utc.wa.gov.
- Per RCW 81.80.075(2), applications for household goods moving permits must be on file for at least 30 days before the permit may be issued. This application will have been on file for 30 days on **March 14, 2021**.
